Thank you for your interest in being a Camp Counselor or CIT. If you meet the Camp Counselor criteria below, please fill out this application and <u>return it to the</u>
<u>Putnam County 4-H Office by April 13th</u> for you to be considered as a 4-H Camp Ocala Counselor/Counselor-In-Training during the week of June 11-15, 2012. Once we determine how many counselors and CIT's are needed based on camper registrations, we will let you know if your help is needed.

- Youth interested in serving as a Counselor-In-Training must have attended Camp Ocala for at least one year previous to this camp year and be 12 years old or older as of September 1st, 2011.
- Senior 4-H Members interested in serving as a Counselor must have previously attended camp as a Counselor-In-Training.
- Youth counselors will be chosen based on experience, character, 4-H spirit, and need for male/female CIT's and Counselors.

4-H Camp Ocala Counselors & CIT's are committed to the following:

A. Attending the mandatory Counselor and CIT trainings on April 21st in Clay County from 10am to 4pm, May 11th starting at 7pm to May 12th at noon (lock-in) in Putnam County, June 8th from 1pm to 4:30 in Putnam County; (This includes ALL Counselors & CIT's)

- B. Attending the mandatory Pre-Camp Meeting at the Putnam County Agricultural Center at 6pm on Friday, June 8th;
- C. Serving at Camp Ocala from Monday, June 11-15, 2012;
- D. Submitting a brief narration to the 4-H Program Office about your camp experiences, which may be used in the 4-H newsletter or forwarded to local media; and
- E. Receiving a <u>partial scholarship to attend camp</u>. CIT's will receive a \$50 scholarship and Counselors will receive an \$80 scholarship.
