Felipe "Fili" Bravo, Jr. was the youngest of nine. He was the youngest, but he was the biggest brother, weighing in at 230 lbs., and stood 5'10" tall. He was a big teddy bear, who adored his eighteen nephews and nieces. Fili was shy and quiet, perhaps because of his older siblings, he learned to stay in the background. He was smart and didn't have to work very hard to get good grades. Fili was enrolled at Merced College Los Banos Campus and hoped to transfer to University of California at Sacramento in the fall. He loved his Mom and Dad . . . and often told his Mom, "hasme de comer, Madre" - which translates into, "make me something to eat, Mother." He chauffeured our parents as their eyesight is failing them. Dad bragged about his son. Although they didn't always agree, Fili always maintained a great respect towards Dad. Fili was a sports fanatic, who could remember stats from different teams, past or present. He enjoyed playing pick up games, such as basketball and football with his nephews at family gatherings. He was a huge Oakland A's fan and also liked the Golden State Warriors and the Dallas Cowboys. Anytime his older siblings gave him advice, he would say, "Don't trip. I got this". Everybody knew Fili was a shy, but easy going funny guy. He had so many friends, who were shocked to learn of how he died, because they knew Fili didn't have any enemies. Fili was considered a real friend, who could never say "no". January 7, 2012, would have been his 24th birthday; sadly . . . we buried our brother a day before. He leaves behind a devastated family and his beloved American Rednose Pitbull, "Killer" - who has cried for Fili every night since he has been gone. Our family masterpiece was shattered on January 1, 2012, when Fili's car was discovered abandoned at Potrero State Beach in Moss Landing in Monterey County, California. His body was found in the trunk of the

My husband, Richard, was born in Canada. He had a dual citizenship. He was a loving husband and father. He had a great sense of humor. He enjoyed spending quality time with his family. He was always more than willing to help me around the house (he loved ironing and household chores), so that we could spend time together. Richard was a good provider and worked very hard to make sure we had all the comforts of home. He was well-liked in our community.

Richard was a workaholic. He worked for a few years at the Phillips 66 service station as manager. He left this position and continued management elsewhere. Richard was also a bar tender when he lived in Nevada prior to us getting married. Richard was in the Navy and proudly served our country. His ambition was to become a Navy Seal, however, since he was not able to see without his glasses, he was not able to qualify.

I have so many fond memories, however, one instance stands out in my mind. Richard had been teaching me self-defense. One day, he hid in the closet, waiting for me to pass by. He wanted to test my reaction and judgment in an aggressive situation. Without thinking, I actually flipped him over. We both had such a great laugh over this. He was such a wonderful and patient man . . . and we were best friends until the day he was murdered. On April 3, 1974, Richard had left home to trade some guns and never returned. Six (6) weeks later (on May 18, 1974), his body was discovered near the mouth of the Malheur River, north of Ontario, Oregon. His hands were bound behind his back and the Medical Examiner, ruled his death a homicide; method of death - drowning. Ontario Police Department believe this murder was the result of Richard being an informant regarding illegal weapons.

To date, my husbands murder has not been solved.

## WORDS FROM JAN

Looking back over the years at all the things I believe to be wrong with the Criminal Justice System, I came to realize the biggest problem appears to be the "band-aid" approach of repairing it. The list of things that are wrong is long. However, today I would like to focus on just one.

When Congress passed the "Hate Crime" laws, it was an effort to guarantee that certain crimes were given the proper attention and an additional amount of punishment. I believe this law is a failure. Remember, my world only looks at and deals with death. The "hate crime" of murder is what I will focus on, as I believe murder, in itself, is hateful. The very act of murder-taking the life of another human being, is hateful. The person who is murdered is gone from this earth forever. The family, friends, co-workers, and acquaintances all suffer to some degree or another. To say that one person is a greater loss is wrong. To say that one family suffers more is wrong. In truth, the loss of a loved one to murder is great and all families suffer in ways that most can never imagine. It is when we try to micro analyze, in an effort to add additional penalties . . . that it all goes wrong!

When a person is murdered, whether homosexual/lesbian or straight, the tremendous loss to the parents is the same. The young college co-ed who is murdered while at her part time job, is no greater of a loss than the young girl working the streets to get by. When a Caucasian boy or girl is murdered, there is nothing to suggest that race will diminish the pain, because of the race of the murderer. Black, brown, white is irrelevant to the families of their dead son, daughter, mother, wife, father, husband, etc. The pain and sense of loss is in no way less or greater, because of the race of the murderer.

Over the years, the press has never taken much time to see what "Victims Week" is really about. The number of cameras at the "March on the Capital" in Sacramento, has never translated into print or TV attention of the real movement. It is usually just the latest "celebrity murder" getting two or three seconds of attention on the evening news.

What I am seeing is an amazing amount of time being spent on one case and thousands of others being completely ignored. This is wrong! Each case deserves attention . . . equal attention to solve the case; and all murderers belong in prison. The system needs to return to simple right and wrong. It is wrong to murder; and if you murder, you will be put to death or spend the rest of your life in prison. There are too many loop holes and too many ways for the murderer to stay on the streets only to murder again and again.

Local law enforcement have limited resources and when the mayor and boards of supervisors are standing with the press on a specific case, all the resources go to that one case. If local law enforcement are allowed to do their job (most of them do an excellent job), more cases might possibly be solved. But, as soon as we begin micro labeling these cases, giving additional attention to some because they are considered a "hate crime" . . . we are no longer mindful of solving all murders, just some murders.

Somehow, we must get ourselves back to the K I S S system within our Criminal Justice System - KEEP IT SIMPLE STUPID. All murders deserve equal attention from law enforcement and the press, not just those labeled a "hate crime". There is no picking and choosing which is more deserving to be solved. Families suffer the same loss and pain. Murder is hateful . . . period.

Remember if you join us . . . together we can and will continue to make a difference.

car, he had been shot to death. Fili was last seen by our brother, Rudy, at around 10:30 p.m. in our home in Los Banos; he was on his way out to celebrate New Year's with friends. We do not know who killed our brother, where or why. Fili was not involved in gangs. He was a simple man, who wanted the simple things in life. He didn't have a lot of material things; just the bare necessities.

Fili's murderer(s) not only took our brother's life . . . they took away our family's peace. We cannot rest, find peace again or begin to recover from Fili's death until the cowardly murderer(s) is caught and brought to justice. There is a \$5,000 reward for information leading to the arrest and conviction of the person(s) responsible for the murder of our brother, Felipe Bravo, Jr. Please do the right thing. ## For The Most Part

Perhaps you have seen the logo on local police department or sheriff department vehicles that reads "Serve and Protect". To the average citizen, the law enforcement presence in their community is appreciated, to say the least. There is trust that local law enforcement is doing all that is possible to serve and protect them and their loved ones.

For the most part, law enforcement takes the responsibility and obligation to serve and protect seriously. The oath administered to sworn peace officers is by no means taken lightly. Each and every day, they risk their lives . . . because of their dedication to their responsibility and obligation. For this we are eternally thankful. "For the most part" is of significant concern. Understand, this is not an indictment of all law enforcement.

The concern is that not all law enforcement employees conduct the due diligence necessary to bring about justice. Justice matters - to victims and families - to communities whereby, when it is not served, criminals get away with . . . murder. Having gotten away with a crime once, how likely is it that the perpetrator will feel shielded and strike again?

The concern is for those law enforcement employees who routinely take the easiest route to close a case. Sometimes human error is served up in the name of "justice". Call it incompetence, laziness, lack of training, neglect of protocol, complicity in a cover-up, or just plain stupidity. Harsh words? Not when families of murder victims are denied justice and murderers are free to kill again. Not when medical examiners are so arrogant and self serving as to dismiss new evidence and not even consider a second review.

Let us take two real-life cases, the first being the case of a 22 year-old female whose death was determined to be a suicide. For the sake of dignity, we will not use her real name, but will call her instead, Teresa. Teresa's death is certainly a tragedy that deserves an accurate accounting of how she went from being a living daughter, sister, friend, to being taken from this earth never to be heard of again. To close the case because the medical examiner determined the manner of death to be suicide, is a terrible injustice - and yet, that is what happened.

From the outset, there was a presumption that Teresa's death was a suicide. The law enforcement agency initially responsible for investigating Teresa's death was a small town police department that lacked the resources to conduct a thorough investigation. The case was transferred to the county sheriff's office due to the suspicious circumstances involving her death.

All information regarding Teresa's death was received from the deceased's boyfriend. Of particular concern were his numerous conflicting accounts of the death scene, position of the body, mental status of the deceased, and answers to questions asked by investigators. The prime suspect/person of interest should have been the boyfriend. However, he was not considered to be a suspect by law enforcement. All information concerning Teresa's death was provided by the boyfriend, and it was this information that led to the manner of death to be suicide. There was overwhelming evidence to indicate foul play, however, there was a rush to judgement and "Serve and Protect" was not a factor. The medical examiner's decision was final and law enforcement - in spite of the numerous inconsistencies in statements from the boyfriend, overwhelming evidence of foul play, and documented reason for the transferring of this case by the small town police department (suspicious circumstances involving the death) - elected to take the easiest route and closed the case. Where is the justice? "Serve and Protect" appears to be meaningless . . . "for the most part".

In our second case, police and medical examiners believed the death of a 49 year-old male we shall call him Henry to be natural causes. Henry's body was already embalmed in preparation for burial when someone at the funeral home noticed something suspicious. The funeral home returned the body to the county medical examiner's office after discovering three bullet holes in

Henry's head. The funeral home, and only the funeral home, is responsible for correctly identifying the cause of Henry's death was murder, and not natural causes, thus averting a possible terrible injustice. What went wrong?

Local law enforcement never visited Henry's home to inspect the body. A paramedic told police he believed the death was natural causes. The police took him at his word. The deceased's girlfriend told authorities that he had had heart problems for years. Additionally, prescription containers for high blood pressure, high cholesterol and diabetes were found in Henry's home. Law enforcement did not collect forensic evidence and, as such, valuable evidence was completely lost. The medical examiner failed to examine the body, electing to instruct the paramedics to transport the body to the local funeral home.

"Serve and Protect"? Again, the easiest route was taken to close a case. Had it not been for the staff at the funeral home, this obvious homicide would have been recorded as a death by natural causes and justice would never have been realized.

What these two cases have in common is neglect. Neglect by law enforcement and medical examiners to meet their responsibility and obligation to "Serve and Protect." The first case was determined by the medical examiner to be a suicide. The second case was definitely a homicide. Both cases, however, required greater consideration than what was given. "Serve and Protect" is seriously damaged by *neglect*, neglect by law enforcement and by medical examiners.

Time and gain, we read in our local newspapers and see on our television sets law enforcement blunders and medical examiners' questionable determinations regarding manner of death. A striking example of the lack of dedication by law enforcement is their unquestioned acceptance of the medical examiners' determination of manner of death. The failure by medical examiners to perform a thorough autopsy is another example. If medical examiners performed autopsies as if the deceased was their own family member, I guarantee *neglect* would be a word of the past. Also, state and/or federal oversight of medical examiners would create a more victim-friendly protocol.

Once a death is ruled a suicide and recorded as such, or bodies and/or evidence are removed, the evidence or body cannot be placed back at the scene.

The time to think about this is now - because no one expects to get bad news or knows how to react when faced with the untimely loss of a loved one.

Anyone who ever experiences the loss of a loved one to homicide or suicide (determined by a medical examiner), where there is significant evidence to support foul play, should remember that all violent deaths should be treated as homicides.

When faced with such an impossible situation, it helps victims families to be informed and know their rights. No one wants to be plagued by guilt and wonder in the years of recovery from the loss of a loved one.

**Demand a complete and thorough investigation, no matter how many hours it may take.**

**Ask for a second or third professional opinion which may be needed to establish the manner of death as suicide, and in all certainty a murder.**

When families of victims know they did everything possible to uncover the truth, they rest easier.

Autopsies are the voice of the dead; medical examiners have a moral and ethical responsibility to listen to those voices.

You are encouraged to contact your state and/or federal representative and ask that they introduce legislation that would create an agency/office that would provide oversight of medical examiners.

## A MOTHER'S QUEST FOR TRUTH AND JUSTICE

On April 7, 2006, Ryan went out for the evening at a local club. When it came time to leave, Ryan gave three young men a ride. A physical altercation occurred and Ryan was robbed. His body was found the next morning; his leg propped on a fence and leaning against a tree with orange electrical cord tied around his neck. His car was stolen and he was not even wearing his own pants. The police and Medical Examiner have ruled Ryan's death a suicide. However, the evidence just does not support this ruling/finding. Nothing makes sense in this case. All my questions to the police are met with indifference and snide comments. All I want is the truth and justice for Ryan. I am mystified by the apathy shown by the Pulaski County Sheriff's Office and the elected officials I reached out to for help. My son mattered. He and I deserve better. My questions deserve answers and my concerns addressed.
