RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration for membership and being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the arena, chutes, mighty buckys, drop barrels, staging areas, approaches thereto and all walkways, concessions and other areas appurtenant to any area where activities related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event; EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, heirs, and next of kin, acknowledge, agrees and represents that he/she has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he/she enter and with which he/she does come in contact and he/she does further warrant he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use.

1. HERBY RELEASES, WAVES, DISCHARGES AND CONVENANTS NOT TO SUE the coaches, participants, sanctioning organizations; specifically, Allied Bull Riders, Medlock Performance Livestock- LLC, Sam and Catherine Medlock, as individuals, or any subdivision thereof; including arena operator, arena owner, officials or any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "Releasees" from all liability to the undersigned, his/her personal representative, assigns, heirs and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to person or property or resulting in death of the undersigned, whether caused by negligence of the Releasee or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in observing, working for, or for any purpose participating in the event.

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the Releasees or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of Releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the sport of bull riding are very dangerous and involve risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the state in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
