The Post-Standard Masters Rules

1. The tournament is certified by the United States Bowing Congress and all participants must be certified by the USBC. This is a single entry tounament. Entrants must be 18 by $2 / 3 / 12$. Junior bowles are not permitted.
2. Distribution of Entry Fee: Prize fund $\$ 20.00$, Tournament Expense $\$ 15.00$. In addition to position prizes, squad prizes for high series and high game may be paid. The prize fund is entry based.
3. Eligibility:This tounament is open to members of the USBC who reside within the geographical boundaries of Onondaga, Cayuga, Chenango, Madison, Osweg, Tompkins, efferson, Oneida or Cortland counties.
4. This is a double-elimination scratch tournament. A bowler, once qualified in positions $1-128$, must lose twice before being eliminated. A bower in the wimers' bracket will not oppose a bowier in the losers' bracket until the.V.. finals, which is a PBA syly top 4 bow down.
5. Last year's champion, if entered, and the top 127 qualifiers enter double elimination finals.
6. Each participant is responsible for the accuracy of his score record, and must subnit that record to the toumament office as directed. 7. Bowles entering the toumament and failing to report for qualifing round foreite entry fee. If a bowler is entering a substitute, toummement managagment must be notified two hours prior to the announced starting time of the qualifying squad. No substitutes will be allowed after the qualifying squad has started. There will be no s substitutions or altemates allowed in any match play round.
7. Bowers in the three-game qualifying round will change lanes for each game as directed by the toumament management. Tournament management
reserves the ighit to move participants to do diferent lanes or different squals in the event of mechanical failures or other unforesseen dififuculies.
8. Double elimination match play will consisis of three games bowled on the same pair of anes. Ties in any match will be broken by a 9th and 1 Oth frame roll off.
9. Premature temmination of the tournament brousht about by a declared emergencry, natural dissster or any othe reason beyond the control of tournament managgement shall cause, to the extent of required thereby, all adverisised pries, gluaranteed or othewise, to be pro-ated in a ccordance with the number of entrants and/or matches having bowled up to the time of such teminition.
10. Any ties for 127 Th place will be decided on a 3 -game roll off on $2 / 6 / 12$ at $5: 30$ p.m. atAMFS Stike n 'Spare.
11. Hals or shorts will NOT te allowed in match play.
13.The toumament director has final say on all disputes.
