

AFFIDAVIT OF SUPPORT FOR INTERNATIONAL UNDERGRADUATE STUDENTS

INSTRUCTIONS

If you will need to hold a student visa, either F-1 or J-1 status, while enrolled at Youngstown State University, you must certify that you have sufficient funds to completely cover your expenses. (If you are a refugee, permanent resident or citizen of the United States, you do not need to complete this form.) A Form I-20 or IAP-66 (used to obtain a visa) can not be issued until both sides of this Affidavit of Financial Support form have been completed, signed and returned with the appropriate supporting documentation to the Office of Undergraduate Admissions. If more than one sponsor will contribute funds, you must copy this form and have each sponsor complete and sign it.

It is essential that you have sufficient funds to support yourself during your entire academic program, at least 4 years for a bachelor degree and 2 years for an associate degree. Youngstown State University does not award any type of financial aid to international undergraduate students. Also, U.S. Citizenship and Immigration Services strictly limit work opportunities for international students. Therefore, you can not plan on paying for your entire degree program by working an on-campus job. If you plan to bring any dependents, you must also provide additional funds for living expenses and insurance costs for each dependent. Enrollment in the University's health insurance policy is mandatory for all international students and recommended for their dependents living in the United States. An exception to this requirement is granted only for students who carry separate health insurance paid for by their scholarships directly to the University.

DOCUMENTATION

In order to be issued a Form I-20, you will need to provide bank statements on bank letterhead or official scholarship or sponsorship letters. The bank statement must show enough deposited funds in savings to pay for at least the first year. All financial documents must be in English and show deposits in U.S. dollars. English translations of foreign language originals will be accepted if signed and sealed by an appropriate government or bank official. Original and official documents must be provided. **You are advised to keep additional, original financial documentation for your use when securing a visa and at the border or port of entry**. Bank statements and official letters should be dated no more then one year form the time of enrollment. If you are currently studying in the United States, please attach a copy of your most recent Form I-20 or IAP-66.

ESTIMATED EXPENSES FOR 2007-2008

On the back of this form, you will need to indicate how you will meet the appropriate "Total Expenses" figure (see below) each year for the anticipated duration of your program. For most students who will not enroll during the summer term, the figure is U.S. \$22,205.00. Living expenses and health insurance are based on 12 months, even though you do not plan to enroll summer term. The living expenses figure is adjusted periodically by the University to reflect students' actual experience in Youngstown, Ohio.

Please note that all amounts below are current 2007-2008 estimates and are subject to change. In the 2007-2008 academic year and beyond, plan for annual increases for all costs of between 5% and 10%. Although you are not required to account for the increase on this form, you and/or your sponsor(s) will have to pay for any increases in tuition and expenses.
