Kim Wayne: Camp Director

Wayne's fifth season in 2013 was one of the best in program history. She guided the Wildcats to the inaugural Big South Regular Season Title with a perfect 7-0 mark in league play, and finished with an 11-7 overall record, tying for most wins in a year. Wayne received the coach of the year honors in 2013. She coached the Big South Offensive Player of the Year while seeing seven 'Cats earn first or second team honors. From 2009 - 2012 she coached 15 National Lacrosse Conference Players including a 2x NLC defender of the year and an NLC goalie of the year. Prior to her time at Davidson, Wayne was an assistant coach at Columbia University, Johns Hopkins University, and James Madison University. She was a four-year starter and graduate of Syracuse University.

Taylor Frink: Assistant Camp Director

Taylor joined the Wildcat coaching staff in 2012 after a year with the Longwood Lancers. A 2011 graduate from the University of Albany, Taylor was a two-time America East All-Conference player and finished her senior campaign with an undefeated 16-0 record.
