In general, visas applications from persons holding Danish passports, who wish to visit for a short period for tourism/business, is processed in 3 4 working days after all documents have been submitted. However, Embassy will not accept any responsibility in cases of delay, which can occur due to various reasons.
- 7. For applicants other than Danish nationals, it is often necessary to refer the application to the Indian Embassy in the country of origin of the applicant. It takes about 5-7 working days to process such applications.
- 8. In the case of applicants with Danish Fremmedpas and certain other applicants, applications are required to be referred to Delhi for decision, and this process takes around 2-3 months.
- 9. Visa fees and telex/telefax charges are non-refundable, once action has been initiated by the Visa office

- 11. Visa fees for foreign nationals other than Danish passport holders may be ascertained from the Embassy.
