“2011 Raider Rookie Zone Halloween Costume Contest,” Official Rules

- 1) How to Enter:** Visit the Raider Rookie Zone, located inside O.co Coliseum – behind sections 234-235 – dressed in your best Halloween costume to get your picture taken with you wearing your costume between 11:00 a.m. and 12:45 p.m. on Sunday, October 23, 2011 or otherwise submit a valid entry by mail as described herein. The costume wearer’s parent or guardian must complete and sign the Raider Rookie Zone Halloween Costume Contest Application, agreeing to the terms of these Official Rules (the individual wearing the Halloween costume and the parent or guardian signing the Raider Rookie Zone Halloween Costume Contest Application are collectively referred to herein as the “Entrant”). To enter by mail, print the Raider Rookie Zone Halloween Costume Contest Application from www.raiders.com and send the signed, completed entry along with a photograph of the costumed contestant (the picture and completed, signed Raider Rookie Zone Halloween Costume Contest Application, whether submitted by mail or in person, are collectively referred to herein as the “Entry”) to: **Raider Rookie Zone Halloween Costume Contest, 1220 Harbor Bay Alameda, CA 94502**. All mail-in Entries must be received by Saturday, October 22, 2011. Entries will be judged by a panel of volunteer judges at The Oakland Raiders in their sole discretion, based on factors including, but not limited to, effort, originality, and creativity. **ONE ENTRY PER PERSON. NO PURCHASE NECESSARY TO WIN PRIZE.**

All submissions become the sole property of The Oakland Raiders and will not be returned. Winners will be contacted by telephone, email, US Mail, or in person by a Raiders representative. If any attempt to contact a potential prize winner is unsuccessful for any reason or if any communication to any potential prize winner is returned as undeliverable for any reason, the prize may be deemed forfeited and awarded to an alternate winner. **By entering the Contest, you expressly agree to be bound by the terms and conditions of these Official Rules and expressly agree to all of the terms and conditions herein, particularly those in section 3 below.** Further, you agree to abide by any decisions by the Raiders or any Raiders related party, and waive any right to claim any ambiguity in these Official Rules or any Entry. You also agree that the Oakland Raiders or any Raiders’ Related Parties or sponsors may contact you regarding events, promotions, or other matters. No responsibility is assumed for late, lost, delayed, illegible, incomplete, damaged, or misdirected entries. All entries become the sole property of the Oakland Raiders and will not be returned. By submitting an Entry or accepting any Prize, the Entrant or winner expressly consents to the use of their name, likeness, and biographical information for all publicity purposes, without further compensation, by the Oakland Raiders, Raider Image, and their collective sponsors, except where prohibited by law. Winner will be solely responsible for any federal, state or local taxes on prizes. Prizes are non-transferable; no substitutions or cash redemptions. “Costumes may not contain any items on the Coliseum Prohibited Items List.”

- 2) Eligibility and Liability:** Contest is open to all children fourteen (14) years old and younger, who fully complete, sign, and submit a valid Entry, including a parent or guardian’s signature on the Raider Rookie Zone Halloween Costume Contest Application. Employees, officers and representatives of The Oakland Raiders, Raider Image, LLC, or their immediate family members are ineligible. Void where prohibited by law. All costumes must be original.

All valid Entries will be considered in one of the following 3 categories:

Category I: boys and girls, ages 0-3 years old
Category II: boys and girls, ages 4-8 years old
Category III: boys and girls, ages 9-14 years old

By submitting an Entry or accepting any prize, all Entrants expressly agree to forever waive, release, discharge, and covenant not to sue the Oakland Raiders ("Raiders") and/or its past and present partners, limited partners, owners, entity owners (and the current and former officers, directors, shareholders, partners, members, limited partners, assigns and employees of any owners or entity owners), employees, agents, attorneys, directors, officers, shareholders, contractors, successors, assigns and insurers (collectively "Raiders Related Parties") for and from any and all claims, debts, liabilities, demands, obligations, costs, fees, expenses, actions and causes of action whatsoever, of every nature, character and description (collectively, "Claims"), known and unknown, including, but not limited to, all those arising out of or in any way related to the Contest; these Official Rules; the legality of these Official Rules; Entrant's Entry; the negligence of Raiders or any of the Raiders Related Parties; the acceptance, possession, misuse or use of any Prize; any travel to or from O.co Coliseum or the Raiders Facility in Alameda; any individual's presence at O.co Coliseum at any time; and any participation in the Contest. By submitting an Entry, Entrant represents and warrants that he or she owns and/or has the authority to release the Claims stated herein expressly agrees to waive the provisions of Section 1542 of the California Civil Code which provides:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

Further, by submitting an Entry or accepting any prize, all Entrants and Prize Winners expressly agree to at all times defend, hold harmless, and indemnify the Raiders and all Raiders Related Parties from and against any and all Claims of any kind or nature whatsoever (including reasonable attorneys' fees and disbursements) arising out of or in any way related to the Contest; these Official Rules; the legality of these Official Rules; Entrant's Entry; the negligence of Raiders or any of the Raiders Related Parties; the acceptance, possession, misuse or use of any Prize; any travel to or from O.co Coliseum or the Raiders Facility in Alameda; any individual's presence at O.co Coliseum at any time; and any participation in the Contest.

- 3) **Prizes:** Prizes will be awarded for first, second and third place in each category and then a grand prize will be awarded to an overall winner of the contest.
 - The third place prize in each category is a \$25 gift card to The Raider Image.
 - The second place prize in each category is a \$50 gift card to The Raider Image.
 - The first place prize in each category is a \$100 gift card to The Raider Image.
- 4) Raiders are not responsible for incorrect or inaccurate entry information whether caused by technical difficulty or human error, which may occur in the processing of the entries.
- 5) Raiders reserve the right to, in its sole discretion, cancel, modify, or suspend the Contest at any time. Raiders also reserves the right to substitute any similar prize or a prize of equal or greater value for any prize listed in these official rules or any other communication regarding the Contest and reserves the right to revoke the prize or discount of any Entrant, at any time, if the Entrant acts in a manner that is, in the Raiders' sole discretion, offensive, harassing, threatening, repugnant, or violent at any time in connection with the Contest.
