LUDLOW BARBER RETIRES

About the time you are reading this, the history of a home-town barber will be coming to an end. Marvin Hensley, owner and operator of the barber shop across from the school, is closing up and locking the door after twenty-two years of business here in Ludlow.

Marvin's personal history goes back to his fifteen years at Wiedeman Brewery where he began to perceive that the end of that business was not too far in the future. Carefully considering what kind of employment he might attain when the need of a new job became reality, and having several friends in the barber business, the idea of becoming a barber himself took root. From that goal he began attending barber classes in Covington while still holding down his job at Wiedeman's, leaving precious little time to even sleep. When the Brewery finally did come to a close, Mr. Hensley had attained his barber's credentials.

He briefly ran a barber's establishment on Holman Street in Covington, and then detoured into an insurance job that was not to his liking, but which did lead him here to Ludlow. One day as he made his way through Ludlow on an insurance sale, he saw the building across from the school with a "For Sale" sign on it, and confidently declared that "that is going to be my barber shop!" In May of 1987 Marvin Hensley opened up his newly purchased barber shop on Adela Street in Ludlow.

Throughout his twenty-two years, his friendly and pleasant personalities, as well as his barbering skills, have attracted many patrons to his shop. One of his more memorable recollections was of the time the movie studio came to town to film "Lost in Yonkers" and kept sending down all their film people to have their hair cut. Another time, an elderly woman wandered in with an old photograph in hand, retelling Marvin the story of her father, Mr. Schubert, who owned and

operated the barber shop in 1919.

Seven years ago, Marvin underwent by-pass surgery, and now as he reaches retirement age, has made the final decision to retire from his barber business here. His home is in Independence where he has two acres of ground to now pursue his love of gardening. Marvin wanted to thank all of the people of our community who have patronized him over the years. He is very appreciative of their business, which helped him make a decent living, and of their friendships. Yes, there has to be a little sadness as he closes the door to the shop and this chapter of his life; but he has great expectations of enjoying his life of cutting grass and growing great tomatoes that is yet ahead.

Marvin, we thank you for your many years of service to our community and wish you the very best in your time of retirement! May all your tomatoes be whoppers. You will be missed!

YOUTH FIREFIGHTER TRAINING PROGRAM

With our economy causing such unemployment and scarcity of jobs for even young people, any opportunity for a future career is a special gift. Ludlow is offering a Junior Volunteer Firefighter Training Program for any youth between the ages of 14 and 18 interested in becoming a firefighter. This is an unique program that began in 1999 under the then Fire Chief, Dennis Campbell. It was eventually put on hold for a year and half, then resumed as of November 2008, and is going full force as of the present. Jeremy Dobbs, a fire fighter engineer, himself a graduate of this program, now heads it up for all those who follow.

The program can hold as many as eighteen youth; eight are already enrolled, so there is still room for more applicants. This is equal opportunity training with two females presently enrolled. Requirements are that your school work level is acceptable, (progress and report cards reflecting that qualification), and that you are healthy enough for the training. The program offers teaching and training in every aspect of firefighting, i.e., use of equipment, climbing ladders, portable extinguishers, sprinklers, foam, and even swift water rescue. The classes are held on a continuing rotating basis, so that whenever you come into the program, you will still be able to benefit from all the classes. They are held every Wednesday evening from 6-9 P.M. at the Fire House. Anyone wishing to enroll can call 581-8600, or simply turn up on Wednesday evenings.

The end result of all this is that after completing the program, the only other requirement is to have Emergency Medical Technician training in order to complete all the necessary credentials to apply as a Firefighter anywhere.

HISTORIC PRESERVATION BOARD AWARDS PLAQUE

The Ludlow Historic Preservation Board at its March 2 meeting awarded Ludlow Architectural Landmark status to the home of Mark and Yolanda Mitchell at 446 Oak Street. The building is a beautiful, early 20th-century house with Victorian massing and Colonial Revival details, which the Mitchells have lovingly restored over a number of years.

Ludlow Architectural Landmark status rewards property owners who have appropriately preserved or restored significant historic buildings. In addition to the usual landmark certificate, the Board gave the Mitchells an "LAL" plaque, which owners of designated landmark properties can purchase, but which was given to the Mitchells in gratitude for their donation of a lifetime collection of Ludlow history artifacts, photographs, and other valuable memorabilia to the City, which hopes eventually to display some or all of this collection in an appropriate setting. LARGE TRASH PICK-UP IN BROMLEY

Saturday, May 9th 2009 has been set as the date for the annual large trash pick-up. This is a great opportunity to rid your house and yard of items no longer needed. Please take this opportunity to remove unsightly junk and debris from your yards and in turn give your neighborhood and community a much needed face lift.

The following items will NOT be accepted: tires, batteries, combustible materials, or anything deemed to be hazardous. Paint will be accepted under the following conditions ONLY: cat litter must be placed in the liquid to solidify it and the lid must be removed. The refrigerant MUST be removed from a refrigerator and a refrigerant recovery statement must be taped to the refrigerator before Rumpke will remove it.

GRANT APPLICATION

The City of Bromley has applied for a crumb rubber mulch grant for the park. The city will have to match 25% of the money awarded. The remaining 75% of the money is provided by the Kentucky Division of Waste Management. The mulch will look like rubber "French fries" or shavings made from scrap tires that are shredded and the wire has been removed. This rubber material does not have to be replaced annually as does the wood mulch and it reduces the number of injuries sustained by children. the refrigerator before Rumpke will remove it.

SCHOOL NEWS

LUDLOW INDEPENDENT SCHOOL DISTRICT RECOMMENDED FOR ACCREDITATION

The Ludlow Independent School District has completed the process for pursuing District Accreditation through the Southern Association of Colleges and Schools (SACS) and the Commission of Accreditation and School Improvement (CASI). The Southern Association of Colleges and Schools (SACS) is part of the world's largest education community through AdvancED. AdvancED represents 30 states, 65 countries and serves over 15 million students world-wide.

In order for a district to be recommended and receive full accreditation from SACS, the district must meet high standards, engage in a continuous improvement process and demonstrate quality assurance through an external review process. The district hosted the external review team on February 22-24th. The purpose of the external review team is complete the following:

- 1. Evaluate the district's adherence to the standards.
- 2. Assess the effectiveness of the district's improvement efforts.
- 3. Review performance results and how the results are used to inform improvement efforts.
- 4. Provide quality feedback with clear recommendations and next steps.
- 5. Make an accreditation recommendation.

The high standards documented by our school district and reviewed by the external visiting team include the following: Vision and Purpose, Governance and Leadership, Teaching and Learning, Documenting and Using Results, Resources and Support Systems, Stakeholder Communication and Relationships, and Commitment to Continuous Improvement. Each standard has multiple indicators of quality that must be met or exceeded as reviewed internally by the district and validated by the The visiting team validated review team. the work of the school district by conducting interviews, making observations, and reviewing documented evidence in the school district. The team interviewed eighty-six (86) stakeholders in our school and community. Board of Education members, parents, community members, business leaders, students, teachers, support staff, and administrators were part of the interview process.

This achievement is one the district and city can be extremely proud to have accomplished. Currently, Ludlow Independent School District is one (1) of three (3) school districts in Northern Kentucky and one (1) of sixteen (16) districts throughout our Commonwealth to earn and achieve this status. This achievement is evidence of the quality educational opportunities provided to all students attending our school district.




