The program allows the State to 9 issue an exception of credit, which will 10 match the Louisiana tax liability to that of 11 a proposed out-of-state site. If all of the aspects are similar, such as being close to 12 the interstates, rivers, modes of 13 14 transportation, that type of stuff. 15 LED can enter into a contract with a 16 company only after the invitation has been 17 extended by the Governor for the company to 18 participate. All taxes are taken into 19 consideration. Property taxes, sales tax, 20 income taxes and all credits are usually 21 also taken into consideration, including 22 quality jobs and industrial tax exceptions. 23 In return, for the equalization exception, 24 the company agrees to maintain and operate a 25 facility in Louisiana with a certain level 0050 of employment. The company also agrees to 1 2 give preference to Louisiana suppliers, 3 contractors and laborers, except where it's 4 not reasonable possible to do so. Another 5 stipulation for this exemption is that the 6 company must designate and set aside at 7 least two percent of the anticipated total 8 goods or procurement to be awarded to the 9 Economic Disadvantaged Businesses within the State, and they can do this by contacting 10 LED's Community Outreach services to get a 11 12 list of such companies. Before us today is Martco and their two 13 14 contracts of two separate sites. Martco is

a manufacturer of engineered forest products

16 producing hardwood lumber, oriented strand board, pine plywood and treated poles under 17 18 the name Roy Omar, Inc. It's one of the largest independent-owned lumber companies 19 20 in the South and has a land base of over 570,000 acres of fine southern pine and 21 hardwoods throughout Louisiana. This land 22 23 base supports the operation of the oriented 24 strand board, plywood and treating 25 facilities in Louisiana. They also operate 0051

At that time, Governor Blanco extended an invitation to Martco to participate in the Tax Equalization Program for both plants, with the understanding that they would not relocate to Polk County, Texas. The invitation for a five-year contract, where option to request a renewal for an additional five years. On March 11th, 2011 my letter to Secretary Moret, Martco requested the renewal for both contracts for the additional five-year period.

The plant in Oakdale is the largest oriented strand board manufacturing facility in North America. OSB is manufactured from waterproof, heat-cured adhesives and

rectangular-shaped wood strands that are arranged in cross-oriented layers similar to plywood. It's located in close to Highway 165 and has access to -- which is easily accessible to Texas and Mississippi by flatbed trucks and vans and also there's railroad facilities. For International shipping, they're conveniently located near the Ports of Houston, New Orleans, Lake Charles, Mobile and Beaumont.

In 2006, the Tax Equalization contract for the plant -- with the contract -- I'm sorry -- Martco agreed to own, operate and maintain the facility in Oakdale, rather than in Texas, with the understanding that they would create and maintain approximately 170 jobs and comply with the Economically Disadvantaged Business requirements as stated in the contract. As of December the 31st, 2010, Martco had 203 employees at this facility with a payroll of 90.6 million dollars.

With the veneer plant in Chauvin, this is a state-of-the-art facility, which produces a full line of high-grade Southern

yellow pine plywood, as well as furniture-grade plywood and panels with high-face requirements. There's a lot of specialized equipment, which is also at this facility. They're located on I-49, which gives them easy access to the interstate, so they can use flatbed as well as vans. They've also got railroad services, and this also puts them close to the same Gulf ports.

According to this contract, Martco agreed to create and maintain the veneer plant in Chauvin with approximately 45 new jobs and also to comply with the Economically Disadvantaged Business requirements. As of December the 31st, 2010, Martco had 372 employees at this facility, with a payroll of 10.4 million dollars. The way the contract will work is if both contracts are approved, Martco is eligible for five more years. They cannot exceed 2.5 million in tax credits per year, any excess tax credits can be carried over

23 to a future year for the five-year period, 24 not to exceed 10 million dollars. 25 Over the past five years -- I skipped 0054 1 around a little bit. All right. For the first five years, they used a total of --2 3 they used an exemption of 4.4 million 4 dollars for the Oakdale site and 1.86 for 5 the is veneer plant. Over the next five 6 years, they're really only expecting to have 7 an exemption of about 2.1 million. There's 8 only one tax that they're really using the 9 exception for. Everything else is pretty much levelled out, and that was for the 10 11 severance tax. 12 LED staff is recommending the renewal of the five-year contracts for both sites, with 13 the understanding that at the Oakdale site, 14 that they will maintain at least 170 jobs, 15 which currently is 203, and the Chauvin 16 17 site, if they maintain at least 45 jobs, s which is currently 372. Although each 18 19 facility has a separate contract, it will be 20 understood that the exemptions apply to both 21 facilities. Total exceptions cannot exceed 22 2.5 with any excess amount to be carried 23 forward, and total exemptions for the five-year period cannot exceed 10 million. 24 25 In your package is a copy of the letter 0055 with the invitation from Governor Blanco. 1 2 Are there any questions. 3 MAYOR HARRIS: Ms. Bigner, would the person from Martco 4 5 like to make any comment? 6 MS. BIGNER: 7 Emily Bruno. 8 MS. BRUNO: I'm Emily Bruno, and I'm the internal 9 auditor. This contact, has been very 10 11 instrumental in allowing us to invest in 12 Louisiana. We invested 400 million dollars 13 in Louisiana between Oakdale and Chauvin.

14 The Oakdale facility was built from the 15 ground up, so it was a completely new investment, and the Chauvin investment was 16 17 an expansion of the existing facility there. And as Susan pointed out, it allowed us to 18 19 create over 500 new jobs in Louisiana. 20 We are planning to continue to invest and benefit from the Equalization contracts. 21 22 Right, our Chauvin facility has maxed out it's Air Quality Permit and we can't 23 physically expand anymore, but we're looking 24 to keep the mill upgraded and in top running 25 0056 1 condition, maybe replacing or updating a dryer. For the Oakdale facility, we're 2 3 thinking about investing in renewable fuel 4 sources by the creation of biomass pellets. 5 So we're looking into that, and we kind of 6 move to a greener environment. As far as threats to our expansion, things that we're 7 8 looking at are regulations on car emissions, 9 truck driver paperwork, logging point source 10 permit requirements that the Corps of Engineers may place on us, having to get a 11 12 permit on every logging job that we do. 13 We're facing uncertain healthcare 14 regulations after 2014. We could also benefit by having cheaper freights out of 15 16 New Orleans, Baton Rouge ports, as opposed to shipping things over to Texas or Mobile. 17 18 The business climate has just greatly improved here in Louisiana, especially in 19 20 the recent most recent three or four years, 21 and the benefit shrunk for this exemption 22 contract as a result of that, because the 23 playing field has levelled out between Texas 24 and Louisiana. And as Susan pointed out, 25 you know, the severance tax is a big tax. 0057 Every time we have to take something off the 1 2 ground, we have to pay a tax on it. Texas 3 still does not have a severance tax, so that

4

would be one benefit that we could continue

5	to recognize from this contract. But we've
6	seen the phase out of sales tax on materials
7	and manufacturing expenses. We are phasing
8	in a pulp and paper manufacturing exemption.
9	The gas and electricity taxes that we use in
10	our manufacturing are gone now, and the
11	machinery and equipment tax is gone as well.
12	And with that said, we would appreciate
13	your consideration in the renewal.
14	MAYOR HARRIS:

16	Ms. Potts Roque has requested the floor.
17	MS. POTTS ROQUE:
18	I would just like to make a motion to
19	approve the renewal for both contracts.

Additionally, 5 our unemployment rating in 2011 has remained 6 well below the National and Southern 7 8 averages, just as it has ever month since early 2008. For the fourth consecutive 9 month, Louisiana unemployment rates have 10 dropped. Louisiana's unemployment for 11 September was 6.9 percent. This has dropped 12 a 0.3 percentage point from August. This 13 14 over the month decrease was tied with the State of Minnesota as a largest rate drop in 15 16 the country. Additionally, the State's 17 unemployment rate has fall a total of 1.3 18 percentage point over the last four months. 19 Louisiana's unemployment rate remains as the 20 third lowest in the South and tied for the 21 13th lowest in the United States. 22 In September, Area Development Magazine 23 said Louisiana rates number 6 among the 2011 24 top states for doing business. This is an 25 overall score, but we also ranked number 3 0060 1 in leading the economic recovery. Louisiana 2 ranked number 3 for business-friendly, and 3 we also ranked number 3 for the overall 4 costs of doing business. 5 In August, Business Facilities Magazine, 6 another publication, issued it's 2011 7 ranking report, in which it declared 8 Louisiana's Fast Start, the number one 9 workforce development program in the Nation for the second year in a row. The magazine 10 also titled Louisiana's economic growth 11 12 potential as the second business best in the

13 14 15 16 17	Nation and ranked the State's business climate as number 7 in the United States. Also in August of this year, Magazine of Corporate Real Estate reported that Louisiana's combination of incentives and
18	economic development agency performance
19	ranks number two in the Nation, and our
20	business climate is in the best shape it has
21	ever been according to Paulina.
22	Also in August, Southern Business and
23	Development Magazine named Louisiana its
24	state of the year for the third straight
25	year. Only this time, in 2011, we stood
0061	year. Only this time, in 2011, we stood
1	alone after time with Tennessee the previous
2	two years. Out of 17 Southern states, no
3	one's economy is performing at a higher
4	level in the pursuit of now jobs in capital
5	investment to Louisiana, the magazine said.
6	In May, something we're very proud of,
7	Site Selections named LED the best
8	performing State Economic development agency
9	in the United States. Louisiana's highest
10	ranking in the nine-year history of Site
11	Selections Competitiveness Award.
12	Bear with me a few more.
13	In March, Site Selection released it's
14	annual Governor's ranking, in which
15	Louisiana's National Economic Development
16	Project's ranking improved 12 spots to
17	number 3 in the United States. That's
18	Louisiana's highest ranking ever in the
19	23-year history of the Governor's top
20	project ranking.
21	Why do I tell you this? Well, these are
22	all signs of genuine progress, and only in
23	Louisiana will you find this kind of
24	economic momentum as you look cross the
25	United States. As we finish our first term
0062	
1	and we head into our second term, we're not
2	stopping yet. We will continue to build on
3	Louisiana's recent economic success as we

4	tell the Nation and the word about the
5	limitless opportunities for growth and
6	prosperity in our great State.
7	Again, thank you for your service to the
8	Board.
