## **Kids Are Safe With Family Child Care Providers**

The Star Tribune series by Brad Schrade, Jeremy Olson and Glenn Howatt on SIDS deaths ("The day-care threat," May 6, 20 and 30, and July 15) has described the intense pain and devastation of losing a child. After great success in lowering the incidence of SIDS since the mid-1990s. Minnesota is seeing an upward trend in SIDS in homes and care programs in the last five years.

There is not one simple answer. Reactions by the public and legislators must be well-informed. Wellintentioned responses can have unintended negative consequences.

We met with Schrade and Olson at an accredited family child-care home to demonstrate what safe. high-quality environments look like, and to dispel the tone and direction taken against the family child-care profession. We shared possible solutions and points not included in their articles.

The Minnesota Sudden Infant Death Center reports that over the past five years, there were 419 infant deaths -- 47 in

licensed family child care, two in licensed centers. 27 in other nonparental care and 343 in parental care. In the previous five years, there had been 358 infant deaths -- 21 in licensed family child care, one in a licensed center. 22 in other nonparental care and 314 in parental care. These figures reflect an increase in infant deaths in all settings.

While 99 percent of licensed family child-care providers, caring for more



than 100,000 children, have not had a serious incident, the tragedy lies in the small percentage who did. Minnesota has safesleep regulations and requires safe-sleep training for licensed providers. Before solutions can be effective, there must be further analysis of individual cases to understand all the contributing factors related to the increase, in

the child's home and in a care setting.

Essential solutions begin with addressing conflicting messages that arise when doctors advise tummy sleep based on a medical need or when parents choose tummy sleep and attempt to direct the provider to do the same. Mixed messages are delivered via marketing companies showing cribs with soft materials and tummy-sleeping babies. Reigniting a "back to sleep" campaign with a clear message is vital.

Solutions that address inadequate funding for high-quality early child care programs are another step. We know that for every dollar spent in the early years, \$17 is saved in later taxpayer expense. We know that the brain is mostly formed by age 5, yet Minnesota spends less than 1 percent of its budget on early care and education. Where are our priorities for children?

Funding for county licensing agencies, which monitor family child-care homes, has been dramatically cut and generally

reduces licensing visits to once every two years or upon complaint. Simply adding regulations or mandating lower ratios will have the unintended consequence of putting more children in unregulated and illegal care.

Solutions are found in education initiatives like those offered through the Minnesota Licensed Family Child Care Association. The Parent Aware initiative is excellent, yet it is limited in capacity. The Race to the Top funds sound like a lot of money, but when there are vast numbers of children who need to benefit, it offers only a few hundred dol-

lars per child on a onetime basis.

Solutions that improve access for parents choosing quality child care are important. Minnesota's Child Care Resource and Referral Agencies provide a wealth of support, yet are unknown or under utilized, as is the Department of Human Services daily e-mail report on correction orders made in licensed facilities. As difficult as the Star Tribune's articles are for grieving families and the vast majority of quality providers, the reporters missed the opportunity to look for solutions that support high-quality care.

It is our hope that future reporting will look at the most current pediatric research to understand the long and complex list of what we could be doing to lower infant deaths and how dollars can be reallocated to implement possible solutions. Our association's mission is to support the highest standard of care for children.

## **Did You Know?**



**M**etal winners from the London Olympics get paid from their countries for winning gold, silver and bronze medals.

- ~Italy pays a gold medal winner \$182,400 which is the highest in the world.
- ~Russia pays nearly \$135,000 for a gold medal.
- ~France pays \$65,200 for a gold medal.
- ~Japan pays \$35,900 for a gold medal
- ~China pays \$31,400 for a gold medal.
- ~Canada pays \$20,000 for a gold medal.

## **Rule Changes for Cribs**

#### New Crib Safety Standard Goes into Effect 12-28-12\*

**B**eginning December 28, 2012, any wooden crib or wooden/metal porta crib provided by family child care homes must meet new and improved federal safety standards. The new standards took effect for manufacturers, retailers, importers and distributors on June 28, 2011, addressing deadly hazards previously seen with traditional drop-side rails, requiring more durable hardware and parts and mandating more rigorous testing.

What this CPSC safety standard is telling all licensed providers in the United States is that if you have a wooden crib or wooden/metal porta crib manufactured before June 28, 2011, those cribs or porta cribs will need to be replaced by December 28, 2012. Old cribs will need to be destroyed and replaced with new CPSC compliant cribs. Licensing will be assessing \$200 fines to all providers not in compliance with



the new crib safety standard set by the Consumer Product Safety Commission as of January 2013.

The CPSC term "non-full-size crib" does not include products with mesh/net/screen or other non-rigid construction. Instead, enclosures with mesh or fabric sides are considered to be "play yards" and are not subject to the new crib standards. If you have a variance for a mesh sided play pen,

pack N play, or play yard you can continue using these until the CPSC updates their safety standard for play yards. They are in the process of reevaluating this safety standard and will give licensed child care homes and centers 6 months to comply with the new safety standard on play yards once it is published in the Federal Register.

Think Small is offering Grants for crib replacement. Applications are available September 1, 2012, and are due back by September 25, 2012. This grant money will require 12 to 16 hours of training to comply. You can call the Grant Line at 651-287-6919 and talk to Helen for an application or print one out from their website starting September 1, 2012, at www. thinksmall.org. If you apply for a grant, you must wait for a grant approval letter dated November 1, 2012, before you can purchase your crib. Look for your neon green postcard from Think Small that details the Child Care Service Grant Application & Guide.

## Ask the Licensor

If a prospective family wants to visit during day care hours to observe their children's interactions with the current day care enrollment (prior to their family signing a contract), is that acceptable per our background check requirements? Also, if we have contractors/service/utility people on our property, what is the protocol for these visits?

There are a number of things to consider whenever you allow someone into your home during childcare hours. You are mandated to protect the health and safety of the children in your care and therefore must provide direct supervision to assure that a person for whom there is not a cleared background study does not have unsupervised access to any child in care. That said, it is also a liability issue as well as a data privacy issue. You, as the licensed provider, must be diligent in assuring that you are supervising children in any and all situations. Here are some things to consider if a person who doesn't have a cleared background study should be in your home:

- If the person may potentially have access to children, they will need a cleared background study. People who fall into this category include house cleaning or lawn service providers, as it is unreasonable to assume that you, as the licensed provider, can supervise the children at all times.
- If there is reasonable cause to conduct a background study, because you, the license holder, have information that would indicate the person (s) may pose a risk of harm to the health or safety of the children in care.

The question posed also begs consideration regarding whether or not the physical environment where the contractors/service/utility people are working is safe and hazard free. This requires that you, as licensed providers, assure that children do not have access to toxic substances or hazardous materials at any time and are providing the level of supervision required to protect the health and safety of the children in care.

Always remember that your Licensor is available to answer any of your questions or concerns!

## Legislative Issues

### Infant and Toddler Care Improvement Act

The Infant and Toddler Care Improvement Act written by Al Franken, included input from numerous child care advocates and organizations. A summary of the bill and all contributing groups are recognized below.

#### INFANT AND TODDLER CARE IMPROVEMENT ACT

Senator Al Franken, Author

#### What Does the Infant and Toddler Care Improvement Act Do?

This bill would authorize the existing appropriations to be set aside specifically directed to address the shortage of high-quality infant and toddler care and improve the overall quality of infant and toddler programs. States would have flexibility in choosing one or more proven strategies for improving the quality of infant and toddler care:

- Provide funds for all child care providers for accreditation or advanced rating on the state's child care system.
- Create networks of family child care providers, parents, and other infant-toddler child care providers, including relative caregivers.
- Support providers in the community by funding organizations to establish statewide networks of infant and toddler specialists to train and consult with child care centers, family child care providers, and relative caregivers.
- Support state initiatives to providers of infant and toddler care for basic care training and expand high quality and advanced professional development through scholarships and coordination with colleges and universities child care courses.

## Improving Child Care for MN Infants and Toddlers

August 1, 2012

**S**T. PAUL, Minn. - Sen. Al Franken, D-Minn., has introduced a bill that aims to improve the overall quality of child-care programs for infants and toddlers. It would allow states to use existing appropriations on strategies that have been shown to improve care.

Lisa Thompson, a child-care provider and president of Minnesota's AFSCME Child Care Providers Together, says the bill would help with training and accreditation programs.

"It would be an enormous help in supporting family child-care providers in the work that we do with children, because these supports can be very expensive, and they can often be endlessly difficult for family child-care providers to access."

Improving care for infants and toddlers is vital, Thompson says, since the majority of a child's brain development happens in his or her first few years.

"Family child-care providers know this. We have children in our homes and in our care for a significant amount of time during those first three years, and the most that we can make of that, the better."

**W**ith recent news reports about the number of SIDS deaths in family day-care settings in Minnesota, Thompson says the bill could also help providers stay current on the latest guidelines to prevent such tragedies.

"Everyone wants children to be safe, no matter where they are, and the priority is making sure that all bases are covered - in making sure that we have all the resources we need."

She says the union helped Franken craft the Infant and Toddler Care Improvement Act, which also would allow funding to be used for programs that rate child-care providers and to create networks of family-care providers to help them with technical assistance and administrative support.

## 6 Lori Castro's Consulting Corner



#### **Writing Lesson Plans**

A great way to start writing Lesson Plans is to make up a template to store your ideas/activities. I use Microsoft Excel and use the borders option to make 8 equal sized boxes. These boxes can be labeled for each area of sorted activities. Some ideas for areas are: Group, Stories/Music, Arts/Crafts, Outside Play, Science/Math, Large Muscle, Manips./Thinking, and Dramatic Play.

**N**ext, think of a theme for each week of the month. When thinking of themes, consider the month you are writing for to come up with your ideas. I put 5 or more activities in each box. One for each day of the week. You can include more activities per area, per day, or less if the kids really like a certain activity for the day. You have the flexibility to change things around when running your own daycare.

**N**ow here's the great thing. Save each lesson plan in a folder on your computer. The following year you can come back to the same lesson plan again and edit it to fit the kids you have at that time.

When Summer comes around, change it up a bit. Incorporate fun "Birthday Type Themes" etc., and use 5 squares in your lesson plan, one per day, to put several special activities in for that Theme of the Week. Then you can go back to your normal schedule when school starts again.

I recently started using Pinterest to get some new GREAT ideas! I put all of my themes into individual boards there. Each time I'm working on a theme I put the ideas I find into those boards. I've even posted my pictures of the activities I've done into these boards as well.

One more bit of information about planning activities is...



#### **Halloween Safety Tips for Kids**

#### <u>Costumes:</u>

My costume is short and snug Baggy sleeves, big capes, puffy skirts can trip you up and catch fire if they brush against jack-o-lanterns or candle flames.

#### My shoes fit

Big Floppy shoes (clown shoes, adult shoes) that are hard to walk in may make you fall.

#### My costume props are flexible

Costume props can hurt you badly if you fall. Make sure swords, knives, etc.

are made of flexible plastic or rubber.

#### The eyeholes in my mask are wide enough

Make sure if you wear a mask that it fits you properly and the eye-holes allow you to see fully. Don't wear a mask that is too loose; it can slop and block your vision. Even better, paint your face instead of wearing a mask. Make-up is a better option over masks.

#### **Streets:**

#### Drivers can see my costume in the dark

Be original with a glow in the dark costume by attaching some reflective tape and stickers. Attach glow sticks to your costume.

#### I'm trick or treating in a group

Don't go it alone while trick or treating. Kids, if you're under age 13, make sure you go with an adult. Older kids should always go with buddies.

#### I cross the streets at crosswalks and intersections

Stop at street corners. Look left, right and left again before crossing, and don't cross between parked cars! Remember, never step into the street without looking to see if a vehicle is coming.

#### Treats:

I make sure my parents check my treats before I eat them Pick only wrapped candy when you trick or treat. Ask your parents to check all treats to make sure they are safe.
