Dear colleagues,

On April 15th and 16th 2010, a joint workshop will take place in the Sheraton Hotel Brussels, Brussels, Belgium, on "EMA Draft Guideline on Validation of Bioanalytical Methods". The workshop is organized by the European Bioanalysis Forum (EBF) and the European Federation for Pharmaceutical Sciences (EUFEPS).

The aim of this workshop is to discuss the current scientific knowledge in the area of bioanalysis, the regulatory requirements and their subsequent translation into the work in the bioanalytical laboratory.

Examples of topics to be discussed include the GLP status of the process of method validation; acceptance criteria of methods to be used in the area of chromatography-based and ligand-binding based assays; sample reproducibility (ISR; study sample reanalysis for PK purposes; and re-integration, to list only a few).

Each one of the four forum discussion sessions ("General Aspects on Validation of Bioanalytical Methods", "Method Validation of Chromatography Based Assays (Small Molecules)", "Method Validation of Assays for Ligand Binding Based Assays (Large Molecules)" and "Analysis of Study Samples"), will be co-chaired by one representative of EBF, EMA and EUFEPS, and will start with a thirty-minute background presentation on the chapter topics to be discussed.

The workshop is organized as an open plenary discussion forum to meet the requirements and expectations of professionals from the generic and the research based industry, CROs, academia and regulatory agencies.

Department heads, project managers, bioanalytical scientists and consultants in R&D, in regulatory affairs, pharmacokinetics, clinical studies, and biostatistics and so forth should attend in order to share their experiences with the scientists from European regulatory agencies. All delegates are invited to contribute actively to the scientific discussions and to support the process toward science driven regulations. Scientists from industry and academia, managers and representatives of company regulatory functions will have a valuable opportunity to discuss the new regulations with representatives from regulatory authorities in Europe.

As we are attempting to produce a new EU model for pharmacy education and training do we need to decide whether to continue to function with the current heterogeneity across Europe in terms of some countries giving only a bachelors (even though the course is for 5 years), and others giving a bachelors(3) + masters (5).

Secondly, should we decide whether the pre-registration period is part of the University course, or is administered by the professional body or the registering body after the course? Or is this a national decision? (the latter is the opinion of Ian Bates- I suppose he is correct that we are unlikely to influence national authorities)

Dear Jane,

This is my proposal to proceed with Work Package 5 :

(1) we wait for further amendments of delegates of EIPG to the list of competences

(2) as soon as this list is ready we present this list to WP3 (I. Bates), to incorporate or integrate them in the list of competences of the basic pharmacist (level 1 , knowledge of)

(3) At the same moment, we will present this list to the Educational Commission of EUFEPS, the Academic section of FIP and IMI (Daan Crommelin) and ask for their opinion and hope they will accept it. So we can enhance our credibility.

(4) Further issues we have to decide :

(i) Is Level 2 (Advanced Master in Industrial Pharmacy) open for other Masters such as Chemists, engineers, etc

(ii) Can this Advanced Master in Industrial Pharmacy be earned in two different ways. Either directly after the pharmacy studies (60 ECTS and stage) or via Lifelong learning in which you collect ECTS in modules during your professional life. Once you have collected 60 ECTS you also receive the Advanced Master. The main part of the modules can be collected by distance learning and a residential week(s) might give added value to the Master.

(iii) I am in favour for both issues

(5) Regarding your mail dated March, 7 : (1) EAAP has presented at several occasions that the model for pharmacy education is a five years curriculum. This is a Master and there is no entry to the profession after a possible Bachelor of three years. (2) I agree with Ian that the registration is a national decision. I agree again with him that it is unlikely to influence national authorities.

**Report:**

- Following a general presentation of the documents that were previously sent to the participants, a brain storming discussion on how to accomplish the goals of WP6 took place. The main conclusions were as follows:
  - Based on the items in the first survey, guidelines on how to implement a Quality Assurance System in the European Faculties of Pharmacy should be drafted and made available to facilitate the certification scheme

- The main conclusions from the first survey should justify a 2<sup>nd</sup> survey based on the adaptation of ACPE draft standards
- In order to implement a certification/accreditation system the current ACPE draft standards should be used for the 2nd survey based on advice from ACPE Assistant Executive Director, Mike Rouse
- This should be presented and discussed during the Catania EAFP annual meeting within a Focus Group composed of 10 (maximum) representatives from different European countries identified through the EAFP Executive Committee.
- A system of "friendly visit" teams followed by evaluation on self-assessment reports and site visits should successively be in place during the implementation phase of the certification/accreditation system (PHARMINE 2)

- The internal QAS for the programme itself was presented by RDL in the form of a global matrix and an individual one for each of the 7 WP's within the PHARMINE programme. The matrix has to be filled up with metrics based on the compliance with deadlines for each of the milestones within the WP's and the availability of deliverables. These should be collected and filed in an appropriate way.

Assessment of the outcomes would take the form of suggestions for improvement which should be classified as relevant and non-relevant.

A letter asking the heads of each WP to make deliverables available to WP6 will be written by RDL, including a template for the compliance with the deadlines for each milestone.
