

## NEW MEMBER APPLICATION FORMS

### Instructions to assist completion:

1. Please ensure that the name of a new member(s) and their address is printed in block letters, legible and in the preferred order. As part of the application form includes the accommodation for joint memberships, any children's birthdates **MUST** be included (see Constitution).
2. Address – member's correspondence address becomes the computer record and is used for all future labelling. Inclusion of the relevant postal code is necessary and obtainable through the NZ Post Postcode book. This ensures cheaper bulk posting for the Club. Please include suburbs where appropriate. The street address, where different, is used for branch purposes.
3. Condition Types - available condition types are printed on the form. The condition of vehicles is computerised therefore it is helpful if the classification options are referred to.
4. Proposer/Secunder - proposer and seconder's names should be **printed** in block letters alongside their signatures and their membership number.
5. The portion pertaining to the Privacy Act **SHOULD** be signed and dated. If this is not completed, the member will automatically be logged as "Approval to allow their information made available". Joint members should both sign. It is not possible to suppress partial details therefore it is all or nothing.
6. Passed by Branch Secretary - this section **must** be completed by the Branch Secretary before the National Office can process the form. It is also important to fill out the Branch details as the Branch is not always clear from the member's address.
7. New member applications should be forwarded to the National Office only after the Branch Committee has accepted them and they are signed by the Secretary. The new member should not send them directly to the National Office. Appropriate payment should be attached. Once processed, the application will be returned to the Branch for their files.
8. New membership is subject to final approval at the Executive Meeting following the date on which they are processed at national level.

**NOTE: If joining as a joint member with an existing member (i.e. joint member as described in the Constitution) an application form must be completed along with the details of the existing member (i.e. name and membership number).**
