Incentive payments will be made in mid-2010 for physicians who are successful e-prescribers during the 2009 reporting period which is January 1, 2009 through December 31, 2009. The initiative is part of the Administration's broader efforts to accelerate the adoption of health IT and the establishment of a health care system based on value. # Quarterly Update to Correct Coding Initiative (CCI) Edits, Version 14.3, Effective October 1, 2008

## **Provider Types Affected**

Physicians who submit claims to Medicare Carriers and A/B Medicare Administrative Contractors (A/B MACs)

# **Background**

This article is based on Change Request (CR) 6169, which provides a reminder for physicians to take note of the quarterly updates to Correct Coding Initiative (CCI) edits.

The National Correct Coding Initiative developed by the Centers for Medicare & Medicaid (CMS) helps promote national correct coding methodologies and controls improper coding. The coding policies developed are based on coding conventions defined in:

- The American Medical Association's (AMA's) Current Procedural Terminology (CPT) manual;
- National and local policies and edits;

- Coding guidelines developed by national societies;
- Analysis of standard medical and surgical practice; and
- Review of current coding practice.

## **Key Points**

The latest package of CCI edits, Version 14.3, will be effective October1, 2008. Version 14.3 of the CCI edits will include all previous versions and updates from January 1, 1996 to the present and will be organized into two tables:

- Column 1/Column 2 Correct Coding Edits; and
- Mutually Exclusive Code (MEC) Edits

News Flash - Flu Shot Reminder - Flu Season Is Coming! It's not too early to start vaccinating as soon as you receive vaccine. Encourage your patients to get a flu shot as it is still their best defense against the influenza virus. (Medicare provides coverage of the flu vaccine without any out-of-pocket costs to the Medicare patient. No deductible or copayment/coinsurance applies.) And don't forget, health care workers also need to protect themselves. Get Your Flu Shot. – Not the Flu. Remember - Influenza vaccine plus its administration are covered Part B benefits. Note that influenza vaccine is NOT a Part D covered drug.
