State and federal laws give certain rights to some who have served honorably in the Armed Forces of the United States. This form allows members of the Oklahoma Public Employees Retirement System (OPERS) to apply for military service credit as defined under Oklahoma State law. To apply, complete this application and enclose a legible copy of your Defense Department Form 214 ("DD214").

PART 2: PLEASE READ THE FOLLOWING INFORMATION, THEN SIGN AND DATE THIS APPLICATION.

There are certain restrictions and limitations on military service credit. For your convenience, a general description of the time periods and conditions under which military service credit can be granted is provided for you on the back of this form. The actual periods for which military service can be granted are governed by 74 O.S. §902(23) and can change from time to time.

If you became an OPERS member July 1, 2000, or after and wish to receive OPERS retirement service credit for your active duty military service, you must purchase the military service credit. OPERS will invoice you for the cost to make such a purchase after the receipt of this form and your military documents.

Employees joining OPERS after June 30, 2003, will not receive credit for military service in OPERS if the credit was already received for the same period(s) of military service in another Oklahoma state retirement system.

Note: Service in the Armed Forces of the United States may entitle you to rights created under a federal law called the Uniform Services Employment and Reemployment Rights Act (USERRA). Those who wish to assert rights under USERRA must contact OPERS and their employer in writing as soon as possible after discharge from military service. Certain limits and restrictions apply. Additional contributions may also be required to obtain retirement credit under USERRA.

Members may be eligible for military credit under OPERS statutes, for purchases under USERRA, or for a combination of the two.

I hereby make application for military service credit as a participating member of the Oklahoma Public Employees Retirement System pursuant to the state laws which govern that system, and I certify that the information I have provided as evidence of my military service is true and correct to the best of my knowledge.

If you are an active member of OPERS who served honorably in the Armed Forces of the United States, you are eligible for up to five years of service credit for specified periods of active military service during which you were a war veteran. The credit is limited to specific periods of active military service listed in paragraph 23 of Section 902 of Title 74 of the Oklahoma Statutes, which includes the following:*

45th Division	September 16, 1940 – December 7, 1941
World War II	December 7, 1941 – December 31, 1946
Korean War	June 27, 1950 – January 31, 1955
Vietnam War	February 28, 1961 – May 7, 1975 (For the period from February 28, 1961 – August 4, 1964, service must be in the Republic of Vietnam)
Gulf War/Persian Gulf War/ Operation Desert Storm	August 1, 1990 – December 31, 1991

Other qualifying periods of military service include wars or military operations which lasted for 90 days or more and are authorized by Congressional authorization or resolution or Presidential Executive Order. Qualifying service is only for the period served in the designated area of responsibility and excludes active duty for training only. Such wars or military operations include, but are not limited to, the following:*

The former Yugoslavia (including Bosnia, Herzegovina, Croatia and Macedonia) <i>By Public Law 104-117</i>	Beginning November 21, 1995 Ending date to be determined
The Kosovo Area <i>By Executive Order 13119 and Public Law 106-21</i>	Beginning March 24, 1999 Ending date to be determined
Afghanistan/Operation Enduring Freedom <i>By Executive Order 13239 and Public Law 107-40</i>	Beginning September 18, 2001 Ending date to be determined
Iraq War/Second Gulf War/Operation Iraqi Freedom <i>By Public Law 107-243</i>	Beginning March 10, 2003 Ending date to be determined
