

# **NE Ohio Storm Water Education Council Workshop for MS4 Operators**

**June 2009**

## **Construction Site Inspection & Enforcement**

This workshop consists of two sessions, a classroom session which is web-based to watch at your convenience and a full-day field tour to be held June 24, 2009. Participants will learn how to conduct a compliance inspection for construction site runoff controls and get practice reading and interpreting a Storm Water Pollution Prevention Plan (SWP3s). The intended audience for this workshop is the MS4 program manager and staff responsible for conducting construction site inspections for municipal storm water programs.

The classroom session consists of three presentations and a video. Participants are strongly encouraged to watch the classroom session before attending the field tour. The classroom sessions are mandatory to receive full continuing education credits for this workshop. To track your participation in the classroom session, you will be required to register when it is accessed. We will notify you of the website address to access the classroom materials once it is known. The classroom session will be available after June 8, 2009, and will eventually be archived at the Ohio EPA Office of Compliance Assistance and Pollution Prevention (OCAPP) website at [www.epa.state.oh.us/ocapp/storm\\_water.html](http://www.epa.state.oh.us/ocapp/storm_water.html) for future use by MS4s for employee training.

Participants will meet at a central location and be taken to a variety of construction sites by bus. Ohio EPA and SWCD staff will lead small groups at the sites and will give participants the opportunity to conduct a mock inspection of at least one site. SWP3s for the sites will be made available to participants prior to the tour. We anticipate that we will visit at least 4 construction sites. Details, including the meeting place, sites, and lunch plans will be available after June 1, 2009. Participants should be prepared for the weather and come with hard hats and safety boots.

Cost for the workshop is \$12.00. This fee will be used to help pay for the bus. Lunch will be on your own, details to follow later. A registration form can be found below.
