This newsletter we want instead to share use thoughts of one of our board members procuring vaccines for our children that are not tainted by the abortion industry.

# Ethical Vaccines or Vaccines Derived from Abortions?

During the last few months the Christian Medical and Dental Association and the Catholic Medical Association have issued papers on the moral considerations involved in choosing vaccines for our children. Ethical problems exist because several of the "voluntary" vaccines were derived from abortions. Frequently, parents were encouraged to abort their children because they "might" have dreaded diseases. The scientists then scavenged multiple dead bodies to find one which actually had the disease so that a vaccine could be created from its cells.

Sadly, some of the most common vaccines still in use in the U.S. were derived from aborted children. The only vaccine presently available for rubella required 47 abortions. Likewise, the chickenpox vaccine is derived from multiple abortions.

Fortunately, many vaccines exist which are not derived from killing children. These are ethical vaccines.

Much more detail, history and ethical analysis are provided at the website, Children of God for Life, www.cogforlife.org. This website tells which vaccines are derived from abortions, which are not, and which unethical vaccines have ethical alternatives. Links to the position papers of both of the above medical associations are included. See especially the article "CMDA calls for Ethical Vaccine Production" posted 6-5-06. The website also tells of efforts to create ethical vaccines to replace the unethical ones and to import ethical vaccines from other countries.

We should all join these efforts. We also must determine whether or not to use unethical vaccines. Summer is a good time for parents to study this subject as this is the time to make these decisions before school resumes in the fall.

We chose to obtain the ethical vaccines Mumpsvax and Attenuvax for our sons rather than inject them with the abortion-derived MMR vaccine. Children of God for Life referred us to Professional Pharmacy, (203) 866-3372, 84 N Main St, Norwalk, CT 06854, to order single doses of these vaccines. Our pediatrician placed the prescription, which we paid for by credit card. We chose to have the vaccines shipped directly to our house because of a snafu with the postal service inexplicably delivering an earlier order to the wrong doctor's office. We took the boys and the vaccines to the doctor's office for the shots.
