GOAL: Acquire skills necessary to conduct an examination of mental status and present the findings in a written report

_____ A. Participants will demonstrate knowledge of the elements of the mental status examination

_____ B. Participants will demonstrate knowledge of the techniques used to evaluate mental status

_____ C. Participants will review sample reports of mental status

GOAL: Acquire skills necessary to competently administer, score and interpret a battery of diagnostic psychological tests including the Shipley-2, Bender Visual Motor Gestalt Test, MMPI-2, and HTP

_____ A. Participants will demonstrate knowledge of the standardized administration procedures for each of the instruments in the diagnostic battery

_____ B. Participants will demonstrate knowledge of the scoring procedures for each of the instruments in the diagnostic battery

_____ C. Participants will demonstrate knowledge of the interpretive procedures associated with each of the instruments in the diagnostic battery, including consideration of cultural influences on test performance.

GOAL: Acquire skills necessary to prepare a comprehensive written report based on the results of the diagnostic psychological test battery

_____ A. Participants will discuss case studies presented by the instructor. The discussion will focus on the interpretation of raw test data and its integration with the patient's history and presenting complaints.

_____ B. Participants will submit raw test data from patients they have evaluated, followed by a presentation of the completed report.

Note: Interns are expected to bring case material to the seminar for group discussion. Case material is welcome at any point during the year.
