We also require that you mail your application to us so that we have an original signature on file. We cannot open a permanent account with a facsimile signature.

The time it will take us to process your application will vary based on the amount of credit you are requesting and the availability of your company's credit information; some applications take a few hours to process, and some take several weeks. When we have completed our review of your application, we will send a letter to you indicating our decision. **In consideration of the issuance of credit for the purchase of Alaska Airlines & Horizon Air air transportation and related services, the undersigned ("applicant") agrees as follows:**

Applicant agrees to pay Alaska Airlines, Inc. ("Alaska") **WITHIN 30 DAYS** of billing date for all charges incurred. Any delinquency in payment may result in the immediate termination of this agreement without notice, and applicant agrees to pay reasonable attorneys' fees and costs of any collection action taken with respect to the delinquency. Applicant also agrees, in the event of any delinquency in payment, to pay a **FINANCE CHARGE** at a periodic rate of 1 1/2 % per month (annual rate of 18%) or the legal maximum.

Any credit card issued pursuant to this agreement is non-transferable. Alaska may revoke, repossess, and/or refuse to honor any credit card without liability to applicant. Applicant will pay all charges incurred by use of applicant's credit card, whether authorized or not, and will notify Alaska immediately if such card is lost or stolen.

Alaska is authorized to investigate references and other data furnished by applicant or by any other person concerning applicant's credit responsibility. Alaska is authorized to assign its rights under this agreement. Applicant will not withhold payment due under this agreement on account of any claim or dispute with Alaska.

This agreement shall not be binding until approved by Alaska and may not be changed except by a written agreement signed by both parties hereto.

APPLICANT REPRESENTS AND WARRANTS TO ALASKA THAT ANY AND ALL CREDIT EXTENDED UNDER THIS AGREEMENT SHALL BE FOR COMMERCIAL PURPOSES ONLY. APPLICANT UNDERSTANDS AND AGREES THAT A SEPARATE AND DIFFERENT AGREEMENT MUST BE ENTERED INTO FOR ANY EXTENSION OF CREDIT FOR PERSONAL (NON COMMERCIAL) USE, AND THAT ANY FEDERAL AND/OR STATE LEGISLATION REGULATING CONSUMER CREDIT IS NOT APPLICABLE TO ANY EXTENSION OF CREDIT UNDER THIS AGREEMENT
