Terrace and Area Seniors' Needs Project Methodology Report

1.0 Project Description

Since the 1980s, Canada's population has been aging. In small towns, the provision of housing, services, and facilities influence the decisions of individuals when choosing to retire in a community. In the City of Terrace, there were about 686 people over the age of 65 in 1991, but by 2001 there were about 1041 people over age 65 (Census, 2001). The increase in the number of older residents, and the increase in the number of residents who wish to remain in Terrace when they retire, have increased the level of interest in how the community, local services, and available housing options will meet the needs of a growing seniors' population. As a result, UNBC and the City of Terrace are working together to assess the needs of older residents.

The purpose of the Terrace and Area Seniors Needs Project is to examine housing and support service needs for seniors in the City of Terrace. Given that Terrace is a service hub for a wider region, interviews and focus groups included people from the surrounding rural areas and neighbouring First Nations' communities. The work was carried out by a research team from UNBC with the goal to provide local leaders with information relevant to decision-making over community planning and infrastructure investments. The project was carried out in the winter of 2006.

This report includes the methodology details and materials for the community interviews and focus groups.

2.0 Methodology

The data and information for this project was collected through 3 methods. These include:

- a review of Census population data,
- key informant interviews, and
- community focus groups.

Census Data

As noted in the Population Background and Trends Report, population data were collected from Statistics Canada's Census database. The Census is undertaken every five years and provides information on the age distribution of local populations. While the age groupings vary between Census periods, it is none-the-less possible to reconstruct the recent population history of the community. Analysis of this population data assessed the following issues:

- 1) the rates of population growth,
- 2) the changing age structure of the population,
- 3) the rates of seniors' retention, as estimated by the age structure of the population over time and the number of seniors' remaining in the community, and
- 4) an estimate of potential growth in the seniors' population based on the current age distribution of the population.

Data for the City of Terrace is derived from Statistics Canada's 'Census Subdivision' (CSD) category. In BC, CSD's correspond with the boundaries of our incorporated municipalities. For the area immediately surrounding the City of Terrace, however, it must be noted that population information is not as straightforward to obtain or compare. It is not collected at a geographic scale that would allow it simply to be added to the Terrace data.

One way to capture this broader sense of a municipality and its surrounding region is through Statistics Canada's Census Agglomeration (CA) category. A CA includes an urban core population (the municipality) together with any neighbouring Stats Can data collection unit where 50% or more of the employed labour force commutes to work in the urban core. Statistics Canada uses such labour market commuter flows as a proxy for a 'functional region'.

Therefore, data in the population report are listed for the City of Terrace, the Terrace CA, the Kitimat-Stikine Regional District, and the province of BC. The goal is to give a range of contexts against which the changes occurring in Terrace can be compared.

A final caution concerns the Census recording of First Nations and aboriginal population data. Such has proved to be a challenge for Statistics Canada and both the City and Terrace CA data should be treated as 'undercounting' First Nations and aboriginal population data.

Research Ethics

Each of the other two research methods used in the study (key informant interviews and focus groups) involved interactions with local residents. Because this is a university based research team, we are bound by standard protocol which identifies that all research conducted with people be sent to UNBC's Research Ethics Board for review and approval. The key informant interviews and the focus group script each passed through this review.

Key to ethics review is that participants are advised of the purposes of the study and that their participation is voluntary. This information is given in the consent forms attached in Appendices A and B. In addition, it is important that participants be advised as to how the research shall protect their anonymity and confidentiality through the process, as well as how through the analysis no linkages are made between the data and the individuals, and that no individuals should be identifiable through the analysis. Again, these points are described in the applicable consent forms. Each participant was given a copy of the consent form.

Key Informant Interviews

Key informant interviews were conducted between January 30th and February 14th, 2006. A copy of the interview guide is attached (Appendix A).

The purpose of the interviews was to provide background information for the future development of a community survey instrument. Key informants were drawn from community groups, service provision agencies, and local government in order to obtain views from people actively engaged in seniors' issues. The key informants were selected from publicly available lists as well as from suggestions received from the City's project advisory committee.

A total of 54 interviews were conducted. As several of the interviews involved meeting with more than one person, a total of 74 people participated in the interviews. A general breakdown of interview participants by community sector is shown in Table 2.1.

Potential interview participants were contacted by telephone to describe the project, how they were identified as a key informant, and to ask if they would be willing to participate. For those willing to participate, we arranged a meeting at a time and place convenient to the key informant. Prior to the interview, they were again advised about the purpose of the research, the issues in the consent form outlining ethics and confidentiality arrangements, and the completed consent form was collected. During the interview, the interviewer took handwritten notes for the responses.

Information from the key informant interviews also helped to identify topics and issues for discussion in the community focus groups. All interviewees received a copy of the final project report.

Focus Groups

The final stage of the research involved a series of focus groups with residents in Terrace. The purpose of the focus groups was to provide additional background information for the City and the possible future development of a community survey on seniors' issues. Focus groups were conducted between February 1st and 16th 2006. A copy of the focus group discussion guide is attached (Appendix B).

Focus group participants were identified in a number of ways. The City's project advisory group identified potential groups that might wish to host a focus group, as well, many of the individuals and groups contacted through the key informant interviews also volunteered to arrange groups to discuss seniors' issue further.

A total of 10 focus groups were conducted for the Project. A total of 76 people were able to participate through these events¹. A general breakdown of the focus groups by community sector, as well as the number of participants, is shown in Table 2.2.

Potential focus group participants were contacted by telephone to describe the project, how they were identified as a potential participant, and to ask if they would be interested in participating. For those who were interested, we arranged a focus group schedule at a time and place convenient to them. Most of the focus group events were held in UNBC's Terrace offices. Prior to each focus group session, participants were again advised about the purpose of the research, the consent form issues around ethics and confidentiality, and completed consent forms were collected.

The focus groups were facilitated by a member of the UNBC research team. A second research team member took notes and operated the tape recording equipment. The focus group information was then compiled into a thematic summary of issues and topics.

All focus group participants received a copy of the final project report.
