

LifeVantage Event Consent and Release of Liability Form

I certify that I am voluntarily participating in LifeVantage's planned excursion events and that I am agreeing to drive or ride as a passenger in a vehicle to/from various LifeVantage Corporation ("LifeVantage") sponsored activities.

I understand that while participating in a LifeVantage event, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any marketing or other legal purpose by LifeVantage.

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES ASSOCIATED WITH LIFEVANTAGE SPONSORED EVENTS, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the Released Parties (defined below), from dangerous or defective vehicles or equipment, or property owned, leased, or controlled by them. Sponsored event activities may include but are not limited to driving, golfing, scuba/snorkeling excursions, catamaran travel horseback riding, Jeep excursions, ocean activities, spa services and any other activities that you choose to participate.

I certify that I am physically fit and am sufficiently prepared for participation in a LifeVantage event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in the LifeVantage event.

I acknowledge that this Consent and Release of Liability Form will be used by LifeVantage and that it will govern my actions and responsibilities during the LifeVantage event.

- (A) *I UNCONDITIONALLY WAIVE, RELEASE, AND DISCHARGE* from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me or my minor children, including my traveling to and from this activity, *THE FOLLOWING ENTITIES OR PERSONS*: LifeVantage and/or its directors, officers, employees, representatives, agents and shareholders (the "Released Parties");
- (B) *I PROMISE NOT TO SUE, TO INDEMNIFY AND TO HOLD HARMLESS* the Released Parties from any and all liabilities or claims made as a result of my or my minor children's participation in the LifeVantage event, whether caused by the negligence or otherwise.

I acknowledge that the LifeVantage event, like any experience, may involve a test of physical and mental limits, and carries with it the potential for death, serious injury and property loss.
