EQUIPMENT: .22 Caliber Pistol (Rule 3.4) **DISTANCE:** 50 Feet

TARGETS: NRA B-2, slow fire target, NRA B-3, timed & rapid fire target.

SOUVENIR AWARDS: NRA will provide to the sponsor a souvenir pin for each competitor.

CLASSIFICATION: All competitors will be classified according to the NRA Classification System in individual and team matches and must exhibit their classification card or Temporary Score Record Book at the Statistical Office. Unclassified competitors will fire in the Master Class if they do not have an assigned classification (Rule 19.6)

ENTRIES & FEES:

Individuals: Entries in individual matches will be made by completing and submitting the attached Registration and Entry Form. Be sure to indicate the date and time that you wish to fire. See Registration form for fees. **Make checks payable to Branch Valley FG & F and return entry form and check to Tom Fewer**. Individual Match entries must be received no later than the Monday preceding the Match.

Teams: Entries made for team participation must be indicated on each individual entry form. Team entries must be made by the Team Capitan prior to start of the firing of the team match. Team entries may be made any time prior to the start of firing of the team match.

Entries are limited to fifty **(50) competitors**. Persons making entry within the time limit who cannot be accepted will be notified by mail and their fees will be returned. Post entries will be accepted up to the range capacity.
