

Transferring your AUSfund account to your KiwiSaver account

Are you eligible?

To be eligible to roll your Australian superannuation account to your KiwiSaver account you must meet the following criteria:

- You must have KiwiSaver account
- Your KiwiSaver provider must be able to accept the rollover (receiving monies from Australia is optional, so you need to check with your provider)
- You must have emigrated permanently to New Zealand
- The whole of your balance in your Australian superannuation fund must be transferred (partial rollovers are not allowed)

Steps you need to follow if you are eligible

1. Complete the application form

Please complete the form 'Request to transfer whole balance of superannuation benefits to KiwiSaver Scheme'

Make sure you complete all mandatory fields. If you do not complete all mandatory fields we may not be able to process your request.

2. Provide Supporting Documentation

To transfer your Australian superannuation account to your KiwiSaver you must provide the following documentation:

a. Proof of residence in New Zealand

You need to provide an official document that shows your current address, for example a copy of your driver licence (if it has your address on it), or a utility bill, council rates notice, or bank statements etc.

A signed Australian Statutory Declaration or New Zealand declaration stating you have permanently emigrated to New Zealand

Under the laws governing the transfer of Australian superannuation monies to a KiwiSaver Scheme account, you must complete either an Australian Statutory Declaration or New Zealand declaration stating you have permanently emigrated to New Zealand.

Who can sign an Australian Statutory Declaration?

Australian Statutory Declarations may only be made before a person whose qualification is on the List of Authorised Witnesses able to witness a Commonwealth Statutory Declaration under the Australian Statutory Declaration Act 1953 and Statutory Regulations 1993.

This includes an Australian Consular or Diplomatic Officer at the Australian High Commission in Wellington, or the Australian Consulate-General in Auckland.

Please note, as stated on the Attorney-General's website:

A person may witness Commonwealth statutory declarations overseas if they:

- Fall within one of the categories on the list of authorised witnesses, and
- Have a connection to Australia.

For example, a member of a police force in Australia may witness a Commonwealth statutory declaration overseas. However, a police officer of a foreign police force cannot witness a Commonwealth statutory declaration.

Australian Statutory Declaration - transfer to KiwiSaver

An Australian Statutory Declaration may be made in accordance with either the law of the state or territory in Australia where it is made or the law of the Commonwealth. Some examples of people who can sign an Australian Statutory Declarations are an Australian: Justice of the Peace, a Solicitor or Barrister holding a current practicing certificate, a Notary Public and members of the police force (in some states).

Important note: A person who intentionally makes a false statement in a Australian Statutory Declaration is guilty of an offence, the punishment for which is imprisonment for a term of 4 years — see section 11 of the Statutory Declaration Act 1959.

Important: Please note New Zealand Justices of the Peace, solicitors etc cannot witness an Australian statutory declaration.

New Zealand Declaration - transfer to KiwiSaver

1. A Declaration made in New Zealand may be made before:

- (a) a person enrolled as a barrister and solicitor of the High Court; or
- (b) a Justice of the Peace; or
- (c) a notary public; or
- (ca) the Registrar or a Deputy Registrar of the Supreme Court; or
- (d) the Registrar or a Deputy Registrar of the Court of Appeal; or
- (e) a Registrar or Deputy Registrar of the High Court or a District Court; or
- (f) some other person authorised by law to administer an oath; or
- (g) a member of Parliament; or
- (h) a person who-
 - is a fellow of the body (incorporated under the Incorporate Societies Act 1908) that, immediately before the commencement of the Oaths and Declarations Amendments Act 2001, was called the New Zealand Institute of Legal Executives; and

- (ii) is acting in the employment of the holder of a practising certificate as a barrister and solicitor of the High Court; or
- an employee of the New Zealand Transport Agency, authorised for that purpose (by name, or as the holder for the time being of a specified office or title) by the Minister of Justice by notice in the Gazette; or
- (ia) an employee of Public Trust constituted under the Public Trust Act 2001, authorised for that purpose (by name, or as the holder for the time being of a specified office or title) by the Minister of Justice by notice in the Gazette; or
- (j) an officer in the service of the Crown, or of a local authority within the meaning of the Local Government Act 2002, authorised for that purpose (by name, or as the holder for the time being of a specified office or title) by the Minister of Justice by notice in the Gazette.
