All sites are 20×20. Water access is available to all vendors, but hoses are not provided. Rental fees are based upon the number of amps required to operate individual booths. No more than one unit is to be permitted on each site, storage units and personal campers of any kind are prohibited within the Fairgrounds. Camping facilities information can be provided upon request. Any damages incurred to the breaker box or to the knockouts will be the responsibility of the vendor to replace, parts and labor.

The McCracken County Fair is not responsible for any booth left unattended during the Fair and make no guarantees with regards to attendance, weather conditions, or amount of sales by the renters. Each vendor must include proof of insurance (liability) when returning this contract to cover all items on the rental site. Booth rentals will be made on a first come first served basis, and all rental fees and signed contracts must be received by May 15th, 2014. The mailing of this contract does not constitute a contract until it has been returned. If no sites are available upon receipt, all monies will be returned. There will be no refunds made on rentals after June 15th, 2014 and all requests for cancellations must be made in writing and post marked at least one week prior to the deadline.

All food vendors must comply with State and Health Department Regulations that govern food handling. Food vendors CAN NOT sell the following items: COTTON CANDY, CANDY APPLES, CARAMEL APPLES, CORN DOGS, FUNNEL CAKES, HAMBURGERS, POLISH SAUSAGE, OR ITALIAN SAUSAGE. The McCracken County Fair will not permit the sale or use of alcoholic beverages within its gates. Pepsi has the exclusive rights on all beverages sold, including water, and the sale of all other beverages is prohibited on Fair grounds. All drink products sold on Fairgrounds MUST be purchased from McCracken County Fair. We have set a price point of 2.50 per bottle for all Pepsi beverages being sold. Any advertising signs other than Pepsi products must be removed. Vendor failing to follow rules and conditions will be subject to immediate removal from Fair grounds with NO refund of any fees.
