<b>Itinerary.</b> Copy of round trip tickets or detailed itinerary for the duration of the trip (Applicant's name must be on itinerary).
<b>Business Letter.</b> A business letter from either the sending company in the US or sponsoring company in Qatar. The letter should be printed on company letterhead stationery, addressed to the Embassy of Qatar, and signed by a senior manager (an equivalent to
Vice-President or above). Business letters from US companies should adhere to the following guidelines:
• Briefly introduce the applicant (please specify employment status/position held in the company by applicant).
• State the nature of the business to be conducted (ie. business meetings, contract negotiations, etc.) and the names and addresses of
companies to be contacted in Qatar.
• Specify the <b>Type and desired Validity</b> of the visa (ie. one year multiple entry business visa).
Guarantee of sufficient funds for travel.

US Agency Letter. Applicants working under contract for a US government project must submit a letter from the US Department of State, sending department, or agency, addressed to "Embassy of Qatar, Washington D.C.", explaining purpose of travel, duration of stay,
and dates of the trip. The letter must contain the applicant's name and the passport number. This letter is in addition to the business
letter from the applicant's company.

Citizens of United States of America can also obtain a visa on arrival at Hamad International Airport, for a stay of up to 30 days.

Type of visa	Requirements
Businessmen	Credentials to prove status.
Tourist	Bank statement for 3 months, and a copy of the resident permit of the concerned resident foreigner.
Residents of GCC countries	Copy of the GCC stay permit valid for at least 6 months. The visa is applicable for persons in specific professions.
Accompanying GCC Nationals	Copy of the GCC stay permit valid for at least 6 months. Visa is limited to persons under the personal sponsorship of the respective GCC national.
Transit Visa	Applicable in special situations - for 2 dayes - and not for transit travelers who do not need a pre-arranged visa and are allowed to enter Qatar under the sponsorship of the concerned airline company provided they have a stop in Qatar for more than 6 hours. until their departure to thier destination according to next pre-determined flight schedule dates.
Joint Tourist Visa	Bank statement for 3 months, Applicable for the nationals of some countries and its holder is allowed to enter any country directly and is free to stay or move to another country before the expiry of the stay period

<sup>\*</sup> The above Visas, except the transit visa, allow their holders to enter the country for one month.

Note: Travel document - holders accompanying official delegations shall be accepted. Holders of this type of travel documents are required to coordinate with a company, their relatives or acquaintances in the State of Qatar to ensure obtaining the needed visas for them.
