OFF THE SHELFLibrary News

At the Family History Center: Footnote (www.footnote.com)

To start out the New Year, let's talk about Footnote. With over 24 million images online and growing, it's one of the most exciting subscription websites for genealogists and historians. And it's available free at LDS Family History Centers.

Footnote is perhaps best known for its efforts to digitize records from the National Archives. The focus is not just on records of genealogical interest, but also records of historical interest, making the website a resource for students and historians as well as genealogists. Millions of images are being added monthly. In fact, you can sit and watch the number grow. Each time images are added, the image counter on the homepage changes. As I write this sentence, the counter is at 24,348,000 images. Wait! It just changed to 24,348,061.

Footnote has a search box at the top of most web pages, where you can search by name, date, place or topic. The basic search returns results that include all your search terms, matching terms from information Footnote has indexed for each image and from annotations added by Footnote members. Reread that: annotations added by Footnote members. Yes, Footnote member users can add annotations to documents. Annotations are explanatory notes or comments attached to the document images. So, it's the Footnote users who add the footnotes to Footnote. That's what makes this website so much fun. It gives us images of historical documents, but it's also user interactive.

There is also a browse feature that allows you to focus your finding efforts by selecting historical eras or specific titles of records to search. The results page includes preview boxes that will help you determine which documents are of interest before you load and view a full document image.

So what kind of documents does Footnote offer? Let's start with the military records.

Revolutionary War Rolls. Footnote has digitized and placed online the Revolutionary War Rolls. These include original muster rolls of the Continental Army. While these have long been available on microfilm, it used to be that you had to know your ancestor's company and regiment

and then search the appropriate rolls line-by-line looking for his name. Now, the rolls are online and searchable electronically.

Revolutionary War Pension Files. Yeah, we know that HeritageQuest Online put them online first. But, HeritageQuest has only *selected papers* from the files. Footnote has digitized the *complete files*. So, whereas you may get ten or twenty pages of a pension file on HeritageQuest, you may find 50 or 100 pages to the same file on Footnote.

Mormon Battalion Pension Files. The Mormon Battalion served during the Mexican War, 1846-1848. These are the pension files, containing, affidavits, correspondence, medical reports, and other documents supporting the pension claims.

Navy Survivors' Certificates. These are more pension files, this time for Navy veterans of the Civil War and later (1861-1910). Currently, only 7% of these files are online. Check frequently for updates.

Navy Widows' Certificates. This collection consists of about 20,000 approved pension application files of U.S. Navy widows and dependents, covering the same time period as the navy survivors' certificates. As I write this article, 95% of the collection is online.

Civil War Pensions Index. This index covers more than just the Civil War. It indexes pension applications of U.S. Army veterans who served between 1861 and 1917, which includes the Spanish-American War and other military engagements prior to World War I. *Important: this is not the same index as we find on Ancestry.com.* The National Archives has two sets of card indexes to the pension files for this time period. One index is alphabetical by name of veteran. The other has the cards grouped by units within regiments, allowing you to identify files for comrades who served with your ancestor. Ancestry has the former. Footnote has the latter. It is also important to note that this index covers Army pensions. For Navy pensions, see above.

Confederate Soldier Service Records. Online are the Civil War Confederate compiled service records for the states of Alabama, Texas, and Virginia. Files for Georgia and North Carolina are currently being added. It's to be expected that records for the other southern states will follow.

Confederate Amnesty Papers, 1865-1867. At the end of the Civil War, President Andrew Johnson proclaimed a general amnesty for most former Confederates. However, (continued on next page) (continued from previous page)

there were some exceptions. Individuals not covered by the general amnesty had to request individual presidential pardons and amnesty, which were evaluated case-by-case. These are the case files for those requests.

Missing Air Crew Reports, WWII. These reports record relevant facts of the last known circumstances regarding missing air crews of the U.S. Army Air Forces, 1942-1947.

That's it for now. Next month we'll look at some other types of records on Footnote.

Digital Sanborn Maps

Originally conceived in the late 18th Century, fire insurance maps provide structural and urban environmental information necessary for insurance underwriters. The Sanborn National Insurance Diagram Bureau was founded in 1867 to produce fire insurance maps nationwide. This New York firm expanded and grew immensely, finally emerging as the Sanborn Map Company in 1902. Eighteen (continued on next page)

years later the company effectively monopolized the insurance map industry. By World War II surveys of 13,000 towns produced over 700,000 sheets now stored in the Library of Congress. The Sanborn Fire Insurance Maps show the size, location, construction and use of buildings in small towns and big cities nationwide, making them useful to genealogists for locating the residences and businesses of our ancestors. Georgia Death Certificates 1919-1927 Online

FamilySearch and the Georgia Archives have announced that Georgia's death index from 1919 to 1927 can be accessed for free online. The online index is linked to digital images of the original death certificates. The index and images can be searched and viewed at http://sos.georgia.gov/archives/ or labs.familysearch.org.

The online index to some 275,000 Georgia deaths is the result of a cooperative effort between FamilySearch Record Services, the Georgia Archives, and the Georgia State Office of Vital Records and Statistics. FamilySearch digitized the records, and volunteers from both FamilySearch and the Archives used FamilySearch indexing technology to create a searchable online index from the digital images of the original historic documents. Certificates include age, county of death, parents names, occupation, gender, race and cause of death.

Homestead Act of 1862

The Homestead Act of 1862 was passed by the U.S. Congress. It provided for the transfer of 160 acres of unoccupied public land to each homesteader on payment of a nominal fee after five years of residence. Land could also be acquired after six months of residence at \$1.25 an acre. The government had previously sold land to settlers in the West for revenue purposes. As the West became politically stronger, however, pressure was increased upon Congress to guarantee free land to settlers. Several bills providing for free distribution of land were defeated in Congress. In 1860, a bill was passed in Congress but was vetoed by President Buchanan. With the ascendancy of the Republican party (which had committed itself to homestead legislation) and with the secession of the South (which had opposed free distribution of land), the Homestead Act, sponsored by Galusha A. Grow, became law. In 1976, it expired in all the states but Alaska, where it ended in 1986.

With this new agreement, full access is provided to more than 24,000 Ancestry.com databases and titles and 5 billion names in family history records. The Generations Network and FamilySearch hope to expand access to other family history centers in the future.



Two Newsletter Delivery Options Available

Individual and family memberships pay the same dues rate. However, we have two new dues rates based on how you receive your *Placer Trails* newsletter.

- 1) For \$10 per year, you can access the newsletter electronically on the Internet; *a paper copy will not be mailed to you*. (This change *reduces* your dues by \$1 for individuals and \$4 for families.)
- 2) For \$15 per year, you can access the newsletter electronically *and also continue to receive a printed, paper copy* of the newsletter in the mail.

A notice will be sent out on the newsletter mailing list when each new issue of the newsletter is published. The notice will include a link to the newsletter file, which you can download or view online. The electronic version of the newsletter is published in PDF format and can be viewed using the free Adobe Acrobat Reader. If you prefer to read your newsletter on paper, but want to take advantage of the

lower dues rate, you can print out the newsletter from your computer at home.

The bylaws amendment, as adopted by the membership on October 27, 2005, changes only ARTICLE 3, SECTION 4, PARAGRAPH (b), which now reads as follows:

The annual dues payable to the corporation by members shall be on a calendar year basis and shall be due on the first day of January in such amounts as follows:

- (1) Electronic rate: \$10.00 per individual or family. This rate shall entitle members to receive electronic only access to and/or delivery of the corporation's newsletter and meeting notices.
- (2) Mail rate: \$15.00 per individual or family. This rate shall entitle members to receive by postal mail delivery printed copies of the corporation's newsletter and meeting notices.

With the electronic rate it is important that you keep the registrar updated with your e-mail address.

Dues are due on January 1.
