PETITION FOR ISSUE DEFINITION DETERMINATION

INSTRUCTIONS: *N.J.S.A. 34:13A-14 et seq.* provides for compulsory interest arbitration of unresolved impasses involving employees of public police and fire departments. It also provides that, in the absence of a mutually agreed upon and approved terminal procedure, the procedure to be utilized shall be one in which the arbitrator chooses between the last offers of the two parties on all noneconomic issues as a package and between the last offers of the two parties on all noneconomic issues on an issue by issue basis. *N.J.S.A. 34:13A-16(f)(2)* contains a definition of economic issues and empowers the Public Employment Relations Commission, in the event of a dispute between the parties, to decide which issues are economic issues and which issues are noneconomic issues. This form is intended to provide notification of such a dispute and it requests that the Commission make a formal determination as set forth at *N.J.A.C. 19:16-6.2(e)*. **Complete Sections 1 through 8. Please type or clearly print. File an original and 9 copies of this petition with the Public Employment Relations Commission. Proof of service of this form is required if it is not a jointly filed petition.**
