

MORTGAGE BORROWER DISCLOSURE & CONSENT FORM

The following form was developed by the Canadian Institute of Mortgage Brokers and Lenders (CIMBL) and the Alberta Mortgage Brokers Association (AMBA) to assist borrowers in understanding their relationship with mortgage brokerages.

MORTGAGE BROKERAGE'S ROLE

The mortgage brokerage's role (and that of their representative, mortgage brokers/associates) and obligations to the borrower and the lender will vary depending on the nature of the service relationship between the mortgage brokerage and the lender or borrower. The following document describes the mortgage brokerage's role and resulting obligations to you.
