ATTENTION ALARM SYSTEM USERS AND APPLICANTS:

If your alarm system is configured to send a Holdup/Panic/Duress signal notification, you are required to have this type of permit. Contact your alarm system company to verify how your alarm system is designed and configured to perform to avoid violations and penalties. The system owner is ultimately responsible for knowing whether the alarm system is configured to send a burglar and/or a holdup/panic/duress alarm signal. *REQUIRED FIELDS

The permit may be revoked for disciplinary reason and/or non-payment of fees owed to the City in accordance with the City of Houston Code of Ordinances, Chapter 11, Article III. A POLICE VEHICLE MAY NOT BE DISPATCHED TO YOUR LOCATION UNLESS THE ALARM COMPANY PROVIDES A VALID PERMIT NUMBER. The Houston Police department has policies and procedures which are not specified in the ordinance. PERMITS ARE VALID FOR ONE (1) YEAR FROM THE ISSUE DATE AND MUST BE RENEWED PRIOR TO EXPIRATION TO INSURE POLICE RESPONSE.

2015 FEE SCHEDULE

IMPORTANT NOTICE FOR RESIDENTIAL AND NON-RESIDENTIAL ALARM SITES

As per Houston City Ordinance, Chapter 11, Article III, if your alarm system is configured to send a Hold-Up/Panic alarm notification, you are required to have this type of permit. Please check with your alarm system company to verify how your alarm system is designed and configured to perform, in order to avoid any penalty that may be associated with a violation.

RESIDENTIAL ALARM PERMIT FEE

- Burglar: \$38.53 each. (Annual renewal required, fee \$38.53)
- Combination burglar and hold-up/panic: \$50.00. (Annual renewal required, fee \$50.00)

NON-RESIDENTIAL ALARM PERMIT FEE

- Burglar: \$110.09 each. (Annual renewal required, fee \$110.09) * **Administrative fee applies, see below**
- Panic/Holdup (known as robbery) \$110.09 each. (Annual renewal required, fee \$110.09) * **Administrative fee applies, see below**
- Combination burglar and panic/holdup: \$220.18. (Annual renewal required, fee \$220.18) * **Administrative fee applies, see below**

RESIDENTIAL ALARM RESPONSE *Burglar alarm systems without a permit are chargeable at \$110.09 per response and /or no response.*

- Three (3) free false burglar alarm calls are allowed for a residential burglar alarm permit holder per year.
- The 4th and 5th false alarm calls are chargeable at \$50.00 each and the 6th and 7th calls are chargeable at \$75.00 each.
- Thereafter each false alarm call is chargeable at \$100.00 each.
- Permits are subject to revocation after the 7th false call and no response.

One (1) free false panic/holdup alarm call is allowed for a residential panic/holdup permit holder per year. Thereafter the 2nd false call is chargeable at \$132.10, the 3rd false call at \$264.22 and the 4th false call is chargeable at \$396.32. Thereafter the 5th false alarm and above are chargeable at \$528.44 (each). *Panic alarm systems without a permit are chargeable at \$290.64 per response and/or no response.*

NON-RESIDENTIAL ALARM RESPONSE *Non-residential burglar alarm systems without a permit are chargeable at \$220.18 per response and /or no response.*

- Three (3) free false alarm calls are allowed for a burglar alarm permit holder per year.
- The 4th and 5th false alarm calls are chargeable at \$50.00 each and the 6th and 7th false calls are chargeable at \$75.00 each. Thereafter each false call is chargeable at \$100.00 each.
- Permits are subject to revocation after the 7th false call and no response.

One (1) free false panic/holdup alarm call is allowed for a non-residential panic/holdup permit holder. Thereafter the 2nd false alarm call is chargeable at \$264.22 and the 3rd false call at \$528.44. The 4th false alarm and above are chargeable at \$660.55 each. *Non-residential panic alarm systems without a permit are chargeable at \$462.38 per response and /or no response.*

ADMINISTRATIVE FEE

An administrative fee of \$ 27.52 shall be collected at time of application for any license, permit or service for which the fee is greater than \$ 50.00. This fee is in addition to the fee for the license, permit or service and includes all renewals regardless of whether or not an application is filed.
