# The New Dining Standards of Practice

## About the Program:

The most frequent questions and concerns CMS receives from regulators and providers focus on dining and food policies. Discuss the New Dining Practice Standards published by the Pioneer Network. This document establishes nationally agreed upon new standards of practice supporting individualized care and self-directed living versus traditional diagnosis-focused treatment.

## Speakers:

**Amy Kotterman** RD, LD graduated from The Ohio State University in 1990 with a Bachelor of Science degree in Medical Dietetics. She is the Corporate Dietitian for United Church Homes where she has been for 20 years. She is a member of The American Dietetic Association, Dietetics in Health Care Communities, the current chairman of the Ohio Health Care Association Dietary Council and a former Examiner for the Ohio Award for Excellence. Amy has spoken on Person Centered Care and Enhanced Dining programs at the Person Centered Care Coalition conference, as well as at previous OHCA conferences.

**Heidi McCoy** RD, LD is the Vice President of Operations for Dietary Solutions Inc. Heidi earned her BS in Medical Dietetics at The Ohio State University. Heidi has over 15 years experience in the field of dietetics all in the long term care arena. Heidi oversees menu development, training of employees, mock dietary surveys and corporate contracts.

## Continuing Education Credits:
