ELIGIBILITY

Free School Meals are available only to children whose parents/guardians are in receipt of the following benefits:

- Income Support
- Income-Based Jobseeker's Allowance
- Employment Support Allowance (income related)
- Support under Part VI of the Immigration and Asylum Act 1999
- Child Tax Credit, provided they are not entitled to Working Tax Credit and have annual income, as assessed by HM Revenue and Customs, that does not exceed £16,190
- Guarantee element of State Pension Credit
