The Organizing Committee of the International Scientific Conference “Problems of assessing risks of development, economic consequences and elaboration of measures for occupational disease prevention” is honored to invite you to take part in this Conference.

The Conference will be held on **April 8-9th, 2015** in Saint Petersburg in the hotel “Astoria / Angleterre” (39, Bolshaya Morskaya str.).

GENERAL INFORMATION

The organizers of the Conference: *the Ministry of Health of the Russian Federation together with the Russian Ministry of Labor and Social Protection, the Russian Social Insurance Fund, the Russian Union of Industrialists and Entrepreneurs, the Russian Chamber of Commerce and the National Association of Occupational Safety and Health Centers.*

THE MAIN TOPICS OF DISCUSSION WILL INCLUDE:

- *Diagnosis of occupational diseases, current approaches to their early detection;*
- *Recent data on comparative assessment of risks and levels of occupational and environmental exposures to various dusts and man-made mineral fibers;*
- *Current approaches to managing possible risks, development of measures for prevention of occupational diseases.*

The participants: representatives of legislative and executive powers of the federal and regional levels, researchers, practitioners, professionals from different countries and regions of Russia, heads of medical and social services, representatives of various industries, occupational pathologists, hygienists, workers of scientific and technical organizations.

The abstracts will be published **before the beginning of the Conference** in a special issue of the magazine “Occupational medicine and industrial ecology”. The magazine is registered by the Ministry of Press and Information of the Russian Federation. The magazine is included in the list of scientific and scientific-technical publications issued in the Russian Federation, in which it is recommended to publish the main results of theses for the degree.

The Conference will be resulted in publishing the book of reports “Proceedings of the International Scientific Conference “Problems of assessing risks of development, economic consequences and elaboration of measures for occupational disease prevention”.

All participants of the Conference will get Certificates.

ABSTRACTS SUBMISSION GUIDELINES

The participants are kindly requested to submit abstracts according to the following requirements. It will speed up the process of the book formation.

Abstracts are published in the text editor Microsoft Word 95 and higher with the following settings:

- 2.0 cm top, bottom and right margins;
- 2.5 cm left margin;
- 1.5 line spacing;
- Times New Roman, 12 pt;
- 1.25 cm indented line;
- 1.25 cm page header/footer;
- text aligning in width;
- portrait page orientation;
- the size of formula symbols is the same as the main text size;
- automatic hyphenation disabled;
- do not use space character to align text (all the words of the main text are separated from each other by not more than one space).

The family name and initials of the authors are printed in the top center in capital letters.

The full name of the organization is printed in the middle of the next line in small letters italics. Legal status of the organization (Federal State Educational Institution, Industrial Group, Federal State Institution of Science etc.) is not specified. If the work is carried out in several organizations, each organization is specified in a separate line. In the names of Russian companies only the first word and proper nouns are written with a capital letter.

The title of the report is written after the blank line in the center, without hyphenation, in capital letters, bold prints.

The abstracts of the report are printed after the blank line with a paragraph according to the requirements mentioned above. The text of the abstracts should include no tables, figures, diagrams, bibliography.

The volume should not exceed 2 pages typewritten (A4).

The Organizing Committee reserves the right to address the issue of the publication.

ABSTRACTS SUBMISSION PROCEDURE

1. Abstracts should be submitted to the Organizing Committee until **January 1st, 2015** in electronic form.
2. The electronic version (Microsoft Word file format) should be sent by e-mail.
3. Together with abstracts the participants should present to the Organizing Committee a free format application containing the following information about the author:
