PARTICIPANT TERMS & CONDITIONS

By registering in Run Gembrook 2012, all participants:

1. Acknowledge that they have read and understand these Participant Terms & Conditions and agree to be bound by them.
2. Certify that, if acting as an agent or guardian of the competitor who will be participating in Run Gembrook and in consideration of the Run Gembrook Organiser accepting the competitor's application to participate in Run Gembrook, they have the authority and do grant an indemnity to the organiser on behalf of each individual competitor.
3. Acknowledge that by submitting an entry application form and participating in Run Gembrook (whether the 2.5km Family Event, 5km Run/Walk or the 10km Run/Walk), they are aware that the event may involve real risks including but not limited to serious injury or even death from various causes including over exertion, dehydration and accidents with other participants, spectators or road users. Participants voluntarily assume all risks associated with their entry application and participation in Run Gembrook or any activity associated with it. Participants consent to receiving any medical treatment that Run Gembrook Organisers consider necessary during or after Run Gembrook.
4. Acknowledge in consideration of and as a condition of acceptance of their entry in Run Gembrook for participants, their executors, administrators, heirs, next of kin, successors and assigns, release the Run Gembrook Organiser, officers, its agents, affiliates, employees, members, volunteers, sponsors, promoters and any person or other body directly or indirectly associated with Run Gembrook, from all claims, demands and proceedings arising out of or in connection with their participation in Run Gembrook and they indemnify them against all liability (including acts of negligence to the fullest extent permitted by law) whatsoever and howsoever caused arising as a result of or in connection with my participation in Run Gembrook including any loss whatsoever of personal property or otherwise. This release and indemnity continues forever and binds the participant's heirs, executors, personal representatives and assigns
5. Will abide by the Run Gembrook rules and guidelines, as varied from time to time and will abide by directions given by Run Gembrook officials and accept that Run Gembrook Organiser has discretion to accept or decline an entry on whatever grounds and to cancel their entry at any time, including without limitation for safety or insurance reasons, or if, in the opinion of the Run Gembrook Organiser, they are unable to complete the event.
6. Acknowledge that the entry fee paid (for participants or another person) in relation to Run Gembrook may entitle them (or that other person) to the opportunity to participate in Run Gembrook on Sunday 21 October, 2012, and to receive any entitlements upon completion of Run Gembrook.
7. Acknowledge that they are not (and no other person is) entitled to a refund or credit of any nature in relation to the entry fee(s) paid (for themselves or another person), for any reason whatsoever, or in any circumstances, unless and to the extent that the Run Gembrook Organiser is required to provide a refund or payment at law.
8. Acknowledge that Run Gembrook may be cancelled due to the extremes of weather or other such unforeseen event where an unacceptable risk exists to the safety of competitors, volunteers and/or the organisers of the event. The decision to cancel the event rests with Run Gembrook Organisers. Prepaid competitor registration fees will be held by the Organisers as credit for entry into the 2012 event on an alternative date. In the event that Run Gembrook is cancelled Run Gembrook Organisers will hold the discretion whether or not to issue a refund.
9. Acknowledge that the Run Gembrook Organiser is entitled to deduct administrative, legal, operational and other costs from any amount (if any) participants would be entitled to receive by way of refund (if payable at law).
10. Accept that the Run Gembrook Organiser may at their absolute discretion; limit the number of entries in Run Gembrook for risk management purposes. Should an entry be received and rejected after an introduced limit has been reached, entrants shall be entitled to a full refund of entry fees only and have no other claims.
11. Acknowledge that if they are entering people other than themselves, they must ensure the registrant is notified and fully understand these and all other entry conditions contained within the entry process.
12. Consent to their details being disclosed to parties necessary in the conduct of Run Gembrook.
13. Consent to the publication and/or use in any form of media whatsoever of their name, image, voice, results, statements or otherwise, without payment or compensation and agree they will reasonably expect to receive marketing material, such as SMS, e-news and entry forms, from Run Gembrook or sponsors of Run Gembrook.
