- (1) CLOSE DATE:** August 1, 2014. Trip is subject to availability.
- (2) FULL PRICE:** Golfer - €4,230 Euros / Approx. \$6,100 USD, based on 16 golfers. Cost is based on 16 golfers; **if fewer golfers participate, cost may be increased.**
- (3) DEPOSIT:** A deposit of 40% per golfer must be received by August 1, 2014, or when the trip is full (16 golfers). **Deposit can be charged in Euros or USD. Please note USD Rate will be based on exchange rate of the day. Euro Prices remain fixed. Participants will be contacted ahead of deposit being processed.**

- (5) FINAL PAYMENT:** Final payment is due July 1st, 2015. You will be emailed a reminder of the amount due on June 24, 2015. **Final Balance can be charged in Euros or USD. Please note USD Rate will be based on exchange rate of the day. Euro Prices remain fixed. Participants will be contacted ahead of final payment being processed.**
- (6) AIRFARE:** Airfare is not included in this package. Participants are responsible for arranging their own air transportation. **A valid passport is required.**

- (7) RESPONSIBILITY:** The suppliers of accommodations and local transportation are acting as independent contractors to the IGA. The IGA shall not be held liable for any act of omission, loss, damage, accident, etc. resulting in conditions beyond its control.
- (8) CANCELLATIONS:** Please note that 40% Deposit is Non-Refundable (Trip Insurance recommended). Any cancellation after Final Balance is paid is also Non-Refundable.
- (9) TRIP INCLUDES:** Seven nights Superior accommodations; six rounds of golf at select courses; luxury chauffeur-driven transfers throughout the trip (includes driver's expenses except gratuity); daily breakfasts; lunches on three days; group photo and action shot on 1st tee of the Old Course; two evening meals (alcohol not included) and a golf gift for each golfer upon arrival in St. Andrews. Caddie fees, trolley and gratuities, if used, are extra. Walking is required at all courses. Carts can be requested but Medical Certificate will be required. Please contact us for full details should you wish to request carts.
