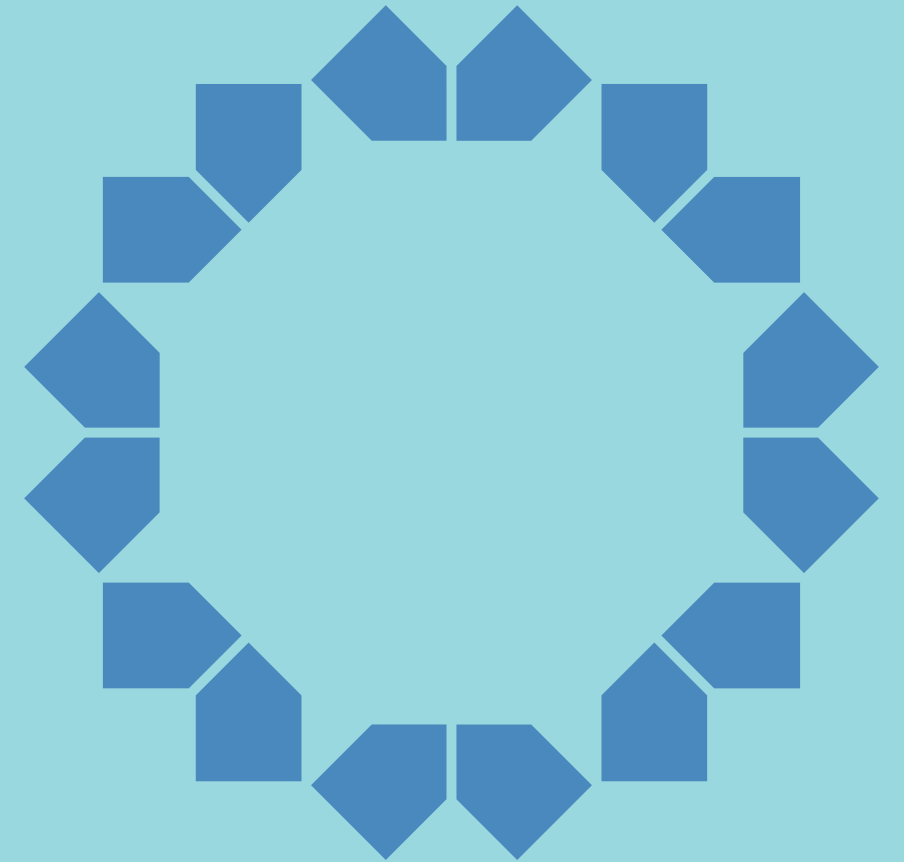

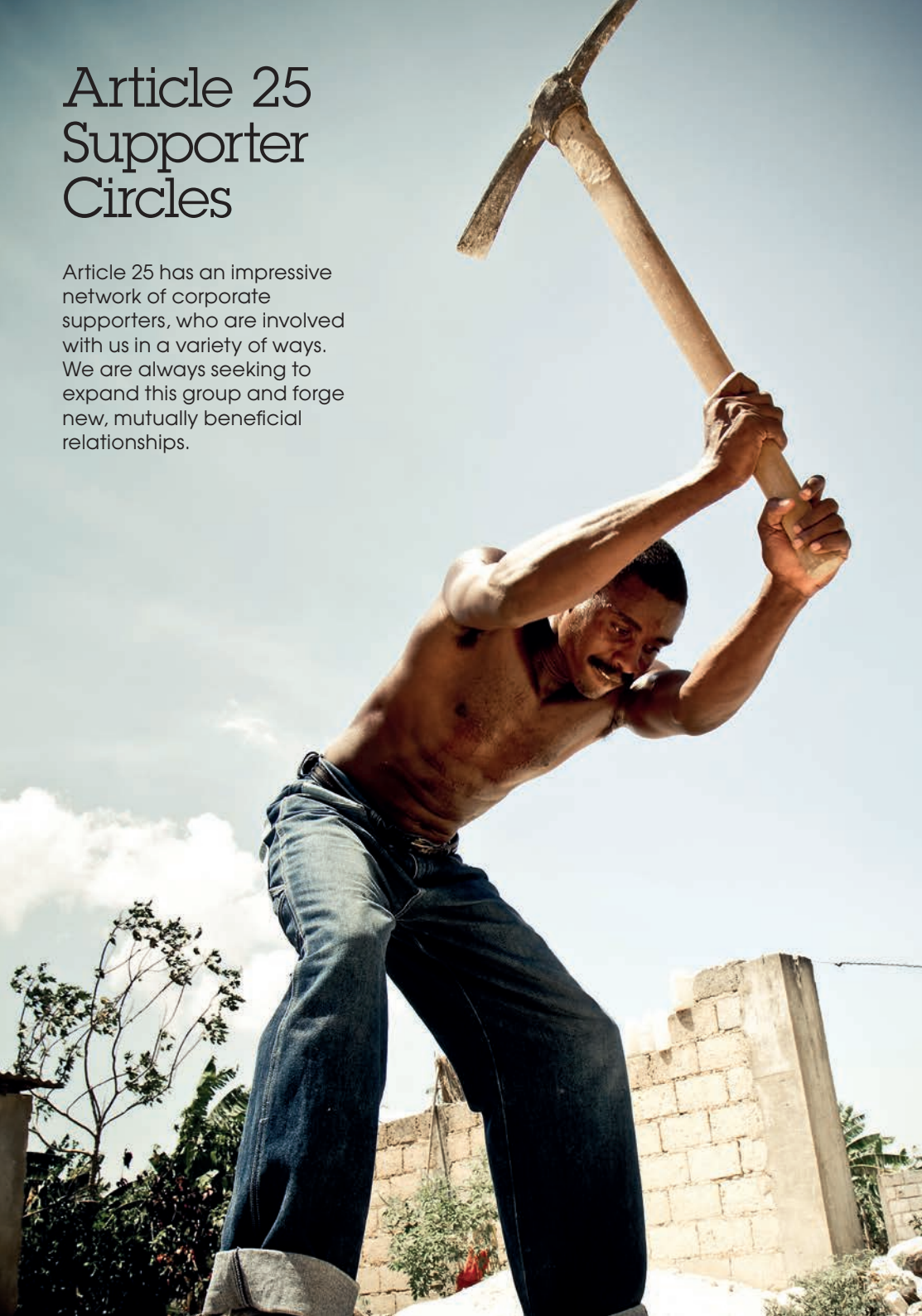

Turquoise Circle £1,200 a year

Our basic package, this may serve as an introduction to Article 25 and offers branding and profile benefits, including:
