Thurston County agriculture forum

Don't forget; invite your friends and interested others, and attend the **LWVTC Agriculture Forum on January 23, 2014.**

Time and place: 7:00 – 9:00 pm, at the United Churches of Olympia, 110 11<sup>th</sup> Avenue SE.

The forum format will be a panel of local farm advocates talking about issues facing farmers in the county. The panel members and their main foci

are: Erik Hagen, WSU Extension, -- an overview of farmland in Thurston County; Steven Drew, County Assessor, -- economic aspects of farming in Thurston County;

Chris Wilcox, Owner of Wilcox Farms, -- a large farmer's perspective;

Lisa Smith, Executive Director of Enterprise for Equity, -- efforts to increase the number of small farms; Loretta Seppanen, Citizen Board Member, South of the Sound Community Farm-land Trust, --efforts to purchase and preserve farmland.

Then, before you know it, we will be distributing Ag Update Consensus Questions developed by a committee at LWVUS.

"Guidance" for responding to the Questions will be provided sometime in January. The date for getting our State materials back to National has been extended to the middle of April. This should allow the consensus to be considered at the 2014 Con-

Fortunately, a statewide Agriculture Study Group was formed last summer. Members of this group have been trying to stay in front of the curve, and they will be doing what they can to assist Local Leagues through the Update process.

The League's compelling civics textbook, *The State We're In: Washington. Your guide to state, local, and tribal Government*, and its companion Teachers Curriculum Guide are now available to everyone as a free online resource ([www.moodle.esd113.org](http://www.moodle.esd113.org)), courtesy of Education Services District 113.

This highly praised civics textbook covers the basics of government and is illustrated with graphs, photos and drawings. It is the only book that describes current and historic tribal governance and their interrelationship with state governments and local government in Washington. It includes sidebars about

people, current and historical events and reflects the ethnic and geographic diversity of our state.

Professionally written for grades 7-12, it is a useful tool for ESL, GED, Basic Ed and Immigration programs. A companion Teacher's Curriculum Guide is also available. Teachers, librarians and the Washington State Indian Education Association endorse it, and over 18,000 copies have been distributed statewide.

## 2014 Legislative Priorities

### Democracy

- ◆ Expand voter registration opportunities e.g., same day & 16/17 year-old pre-registration.
- ◆ Reform election systems so all communities have equal opportunity to elect candidates of their choice.
- ◆ Reform campaign finance laws.

### Agriculture

- ◆ Promote productive farms by responsible, sustainable agriculture practices & policies.
- ◆ Adopt policies that ensure farms are economically viable, reduce barriers to entry to farming and increase local food production and distribution.

### Budget

- ◆ Adopt balanced, fair, adequate & flexible state revenue policies to meet critical needs.

### Education, Early Learning, Families and Children

- ◆ Fully fund Basic Education as defined by the Legislature and required by the State Constitution and the State Supreme Court.
- ◆ Protect and enhance basic needs funding and programs for families and children.
- ◆ Promote early learning and the well-being of all children by providing high quality services through policies, practices and funding.

### Gun Responsibility

- ◆ Require criminal background checks for all gun sales.
- ◆ Reduce gun violence through education and intervention programs.

### Health Care

- ◆ Ensure access for all residents to comprehensive, uniform, and affordable health services, including the full range of reproductive services.
- ◆ Use the Affordable Care Act to fund public health, health coverage for low income populations, Medicaid expansion, and continuity of care as individuals move between subsidized care options.
- ◆ Provide incentives to expand primary care provider options in under-served areas.

### Natural Resources

- ◆ Adequately fund State Parks to protect them as public assets.
- ◆ Protect water resources from depletion or pollution.
- ◆ Implement best practices in greenhouse gas emissions, air and water quality.
- ◆ Incorporate environmental quality & public health impacts in transportation decisions.
- ◆ Eliminate toxic chemicals in children's products.

### Transportation

- ◆ Provide adequate funding to implement the comprehensive and balanced statewide transportation plan (Washington Transportation Plan 2030).
