Rain Athletics 2014-2015 Financial Commitment Packet

We at Rain Athletics understand that all-star cheerleading is a very expensive sport. It is our promise to you, that we will always provide the best service available for the most competitive price in our area. All fees are outlined on the *Rain Athletics Price Sheet*. We encourage you to keep a copy of the price sheet for your records throughout the season.

If at any point in the season the Rain Athletics Staff feels that a team would need to make a change to the music or dance section of the routine, you may be asked to pay an additional fee no more than \$30.00. This does not happen often, but we do what we must to assure our athletes have the best chance at success every time that they take the mat.

Rain Athletics WILL NOT issue any refunds for fees paid if an athlete is asked to leave the program or willfully resigns from the program. This includes, but is not limited to, monthly fees (tuition, competition fees, music & choreography fees), apparel orders, uniform, makeup, etc.

If an athlete choses to leave the program mid-season (as outlined below), the family will be responsible for paying monthly tuition (\$110.00 per month) for the remaining months of the season. Rain Athletics will not refund any money that has been paid up to that point, for any reason.

Should an athlete become injured mid-season, the family will be obligated to continue payments only if the athlete plans to return to the program in the same season. If the athlete is unable to finish the season, a signed letter from the doctor tending to the injury must be presented, and all future fees will be waived (The doctor's note must state the injury and the date that the athlete is cleared to return to normal activity). If a letter is not presented to Rain Athletics or if a letter is presented to Rain Athletics and the date that the athlete can resume normal activity is within the competitive season and the family still decides to resign, the family is still responsible for the monthly tuition as outlined above. No refunds will be made if an athlete is unable to continue the season due to injury.

Rain Athletics will not replace or repair any apparel (uniform, bow and practice-wear included). We are always offering new designs and clothing that sometimes are embellished with rhinestones and other couture embellishments. We strongly encourage following all washing instructions, and understanding the delicacy that comes with these sensitive additions.

Rain Athletics reserves the right to refuse a sale of any apparel, class, or private if you have an outstanding balance. We will gladly allow you to take the class or buy the shirt as soon as your account is up to date.

Any athlete who joins a Rain Athletics team mid-season, IS responsible for all back fees for the season with the exception of monthly tuition (\$110.00). Monthly tuition is a price that is included in the bulk monthly fee.

All fees listed on the price sheet are due on the respected dates outlined. Rain Athletics allows a 5-day grace period to pay all fees. A late fee of \$25.00 will be added to the balance on the sixth day if the payment has not been made in full. We will be strictly enforcing this policy this season.

A late fee will only be applied once per fee. For example, if you are 6 days late for the \$100 charge on January 1st, and are 6 days late for the \$100 dollar charge on February 1st, your new balance would be \$250.00.

Rain Athletics defines the all-star competitive season as the time from the date in which you sign the registration form, to the day following the last scheduled competition.

FOR ATHLETES JOINING AFTER REGISTRATION: If I am signing my financial commitment agreement after the official Rain Athletics registration date, I understand that I have two weeks to cancel my financial commitment agreement with Rain Athletics. In addition to the terms above, if I chose to cancel my financial commitment agreement within the two weeks but my child was choreographed into a routine during that time, a rechoreography fee of \$100.00 will be charged to my account in order to cancel my financial commitment agreement.
