You are invited to bid on the construction for the Water Supply Improvement project in the Town of Bristol, New Hampshire. Construction could start this Fall or be deferred until Spring of 2010 at the contractors option. This project involves renovations and an addition to the existing Storm Center Well site off Hall Road and a new Hillside Booster Pump Station at the intersection of Hillside and North Main streets both in Bristol, New Hampshire. Work items include erosion control, general site work, road reconstruction, paving, dewatering, site demolition, water tank demolition & utility abandonment, site utilities, rock and ledge removal, surface restoration, Redi-Rock retaining wall, selective building demolition, cast-in-place concrete, pre-cast concrete plank, concrete topping, block & brick masonry, miscellaneous metals, galvanized railings, rough carpentry, roof blocking, vapor barriers, damp proofing, waterproofing, rigid insulation, single-ply roofing, metal flashing, caulking and sealants, metal doors, frames, finish hardware, special coatings, painting, process equipment (pumps, tanks, chemical feed systems), instrumentation and controls, SCADA computer alternate, process piping, plumbing, HVAC, and electrical.
