**Tournament Rules**

1. This is a USTA Category 1 and an ITF Grade 2 sanctioned tournament. In order for singles players to earn ITF ranking points, they must have an IPIN. To obtain an IPIN go to [www.itftennis.com/ipin](http://www.itftennis.com/ipin). Matches to be played in accordance with rules and regulations of the USTA. All USTA members, regardless of nationality or residence are eligible.
2. All entrants must present a valid USTA membership unless entering via TennisLink. Sign up or renew membership online. Players must meet age level of event by 12/31/2013.
3. **TennisLink entry preferred.** Register at [www.usta.com](http://www.usta.com). Enter tournament id to locate tournament. Mailed or faxed entries must include fee. Per person: First event \$86.50\*. Second event \$54.25\*. \* Includes processing fee. Cheques/money orders payable to H-F Racquet & Fitness Club. Fax/email entries must include charge card number. No refunds after entry deadline.
4. Player may enter two events. Draws published at [usta.com](http://usta.com) prior to start of play. Participants are responsible for visually checking draw at HFRFC prior to first round of match play.
5. Matches will be the best of three tiebreak sets. Using the Coman tiebreak. Default time is 15 minutes. PPS in effect. Check in 30 minutes prior to match time, ready to play,
6. WILSON is the official tournament ball.
7. A Full Feed-in Consolation tournament (through quarter final losers in main draw) will be scheduled in both singles and doubles. For less than 17 players in any event this will become a Modified Feed-In. 3<sup>rd</sup> place playoffs will be scheduled in all main draws.
8. Gold and silver balls will be awarded to the USTA National Championship Finalists. Bronze balls will be awarded to 3<sup>rd</sup> place and prizes will be awarded to 4<sup>th</sup> through 6<sup>th</sup> place.
