Freshman students may apply for a maximum of \$3,500 annually. Sophomore students may apply for a maximum of \$4,500 annually. Students become sophomores after they have completed 32 credits or had an equivalent number of transfer credits.

Independent students may apply for an additional \$6,000 annually. Dependent students may apply for an additional \$2,000. These additional funds are always unsubsidized.

Student loans may be subsidized or unsubsidized. Unsubsidized loans have interest accrue while the student attends college unless the student chooses to capitalize the interest.
