If the matter for which you are seeking a building permit, authorization to proceed with a proposed project, or other form of approval which is required to be presented to Village Council and/or the Planning & Zoning Commission, you are **strongly encouraged** to attend all meetings at which the matter will be discussed. While the Village certainly welcomes the participation of the contractors, architect & other professionals who represent the owner, there are many instances when approval of a proposed project is conditioned on the owner committing to take (or to refrain from taking) certain actions. Without the owner being physically present at the meeting, such a project may need to be tabled, thus resulting in an unwelcome delay. If you are **not** planning on being present at the meeting for which your project or matter is scheduled, the Village would appreciate as much advance notice as possible.

The proposed work must be done in accordance with The Orange Village Codified Ordinances, the approved plans, specifications, codes, and standards. Separate permits which may be required for the proposed project include: electrical, HVAC, gas piping, plumbing and electric to septic.

It is the duty of the General Contractor to ensure that all required inspections are scheduled and all work installed has been approved by The Orange Village Building Department prior to proceeding to the next phase of construction. The General Contractor is responsible to obtain a <u>Final</u> inspection at the completion of the project. This permit becomes null and void if work or construction authorized is not commenced within 12 months, or if construction or work is suspended or abandoned for a period of 180 consecutive days at any time after work is commenced. I hereby certify that I have read and examined this application and that all information is true, accurate, and complete. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. I authorize The Orange Village Building Department to enter this property for the purpose of site inspections for the duration of this project.
