AGREEMENT REGARDING RISK OF INJURY AND RELEASE RELEASE AND WAIVER OF ALL CLAIMS

I hereby apply to participate in the Gus Macker 3-on-3 Basketball Tournament (the "Tournament") Otsego, MI, on August 29-30, 2015.

I understand that participating in the Tournament will expose me to above normal risks of injury or harm. I agree that I am responsible for my own safety.

I understand that I am solely responsible for any injuries which may occur to me as a result of my participation in the Tournament and I specifically waive my right to bring litigation against the sponsors and specifically release any right which I have to assert a negligence claim against the Tournament sponsors, their agents or representatives.
