## NASHVILLE USBC WBA LOCAL TOURNAMENT RULES

1. All entrants must be members of the Nashville USBC WBA.
2. The tournament shall consist of a 4-woman team event, a doubles event, a singles event, and an optional all events. Three consecutive games will be bowled in each of the team, doubles, and singles events. The optional all events shall be comprised of 9 game total. Only the first appearance in each event shall be considered for the optional all events. The tournament shall be handicapped and based on $90 \%$ of 210 .
3. A bowler may enter the team event three times provided at least two bowlers will be changed. A bowler may bowl twice in the doubles event with different partners. Bowlers are permitted to bowl only once in the singles event. Bowlers entering the doubles event must also enter the singles event (first appearance only). Championship in each event (team, doubles, and singles) will be awarded on a handicap basis. The optional all events champions will be declared on a handicap as well as scratch basis. In the event of a tie, co-champions shall be declared.
4. Only Nashville USBC WBA/BA averages are acceptable and will be accepted in the following order:
A. Highest 2013-14 winter season (21 games minimum)
B. Highest 2013-14 summer season ( 21 games minimum) This average must be certified by the league secretary and submitted by the team captain prior to bowling.
C. Current Nashville USBC WBA/BA average ( 21 games minimum) as of the date of first schedule appearance. Certification must be presented prior to bowling.
D. If none of the above apply, the bowler will bowl scratch (210).
E. Rules 319A \#2, 319D, and 319E do not apply.
5. The team captain must check-in her team once they are all present, at least 30 minutes prior to the scheduled time for the team event. Individuals participating in the doubles event must check in at least 30 minutes prior to the scheduled time for the doubles event. A bowler arriving after the game has begun must start bowling beginning with the frame being bowled unless a she has been replaced by a substitute. If there is no substitute, the tardy bowler will receive a zero for each frame missed. If she has been replaced by a substitute, the substitute shall complete the series.
6. Singles are bowled immediately following doubles. If a bowler is not present at the beginning of the doubles event, the bowler present will bowl her singles event first. If her partner has not arrived by the completion of the scheduled doubles event, and a substitute is unavailable, the bowler present may bowl her doubles event in order to qualify for all events.
7. Substitutes are allowed when necessary. No more than 3 substitutes will be allowed on a team and not more than 1 substitute will be allowed on a doubles event. The tournament director must be notified at least 1 hour prior to the scheduled event. In the event of an emergency during team and/or doubles events, a substitute shall be permitted. In such an emergency, the combined score of the bowler and the replacement will count toward total pin fall in the affected events. If a substitute is not available, only the actual pin count will count toward the bowler's score.
8. Entries close January 10, 2015. The lineup shall be the same as shown on the entry form. Checks or money orders should be made payable to Nashville USBC WBA. No entry fees will be refunded once the event has been scheduled. Any returned for insufficient funds will be charged $\$ 40.00$ in addition to the face amount of the check and will be payable by cashier check or money order.
9. No food or drink will be allowed in the bowling area. Cell phones must be turned off or placed in a silent mode during participation. Only scheduled participants and authorized personnel are allowed in the bowling area.
10. Prize fund will be paid $100 \%$ with a prize ratio of $1: 10$. Prize checks must be cashed within 60 days of the date on the check.
11. TEAM ORGANIZER BONUS: An organizer submitting 5 team entries will receive her team entry fee free. By submitting 10 team entries she shall receive free entry to doubles and singles events in addition to her team entry fee. In order to qualify for this bonus, an organizer must submit all entries and associated fees in a single envelope.
