Attached is your application for a pistol permit(s). Applicants for purchasing a handgun must meet the following qualifications:

- 1) Must be age 21 and a resident of Anson County for at least 6 months.
- 2) No felony conviction, no conviction involving guns or drugs.
- 3) No "pending" court action.
- 4) No history of mental illness or drug abuse.

If you meet the above qualifications, you may qualify for a pistol permit. The attached form must be completed, printed, and presented in person at the Sheriff's Office along with a \$5.00 application fee.

DO NOT MAIL APPLICATION

Applicants are required to personally deliver forms to the Sheriff's Office.

Your application will be processed and if approved, your permit will be mailed to you after a 5 working day waiting period.

Should your application be denied, you will notified in writing and given the reason for denial.

Incorrect or incomplete information on this application will result in your permit being denied. The \$5.00 processing fee cannot be returned.

Once approved, the permit allows you to purchase, exchange or trade one (1) handgun with any authorized person or dealer in North Carolina.

SUPPLEMENTARY QUESTIONS FOR APPLICANTS FOR A PERMIT TO PURCHASE A HANDGUN

Prohibitions applicable to certain aliens. Federal law makes it unlawful for aliens who are illegally or unlawfully in the United States to receive or possess firearms. In addition, subject to certain exemptions, aliens who are in a non-immigrant status are prohibited from possessing or receiving firearms in the United States.

A non-immigrant alien is not subject to this prohibition if the alien:

- 1) is in possession of a valid hunting license or permit lawfully issued in the United States;
- 2) is an official representative of a foreign government who is accredited to the United States Government or his or her government's mission to an international organization having its headquarters in the United States; or
- 3) has received a waiver from the prohibition from the Attorney General of the United States.

See 18 USC 922(y)(2) for additional exceptions. In order to determine whether applicants who are not U.S. citizens are prohibited from possessing firearms under Federal law, it is necessary to obtain answers to the following questions.

5) \	What is your INS-issued alien number or admission number?

7) /	Are you a non-immigrant alien?
