I. **EQUIPMENT, RENT & TERMS OF RENTAL AGREEMENT:** The undersigned, as Lessee, hires from *MEGAJUMPS Castle & Party Hire* as Lessor, unit(s) identified as \_\_\_\_\_

II. **DELIVERY:** To the street address "Delivery Address" for the delivery and subsequent pick up of the unit at the specified time.

III. **TRANSPORTATION EXPENSE:** Except as provided herein, all charges in delivering and subsequent pick up of the unit(s) with respect to the delivery address are included in the hire fee. In the event that the unit is not returned at the appointed time by Lessee to *MEGAJUMPS Castle & Party Hire*, a \$50 transportation fee shall be automatically imposed.

IV. **GENERAL RULES TO FOLLOW DURING USE OF THE UNIT(S):**

- a) Only compatible age groups and size shall play on the unit(s) at the same time.
- b) All riders **MUST REMOVE SHOES** before playing on the unit(s). Socks are permitted.
- c) To avoid neck injuries, **FLIPS OF ANY KIND ARE NOT ALLOWED.**
- d) Children’s safety depends on you. **YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED.** As the LESSEE of the *MEGAJUMPS* unit(s), **THE SAFETY OF ALL RIDERS IS YOUR RESPONSIBILITY.**
- e) Absolutely **NO SILLY STRING, STREAMERS, LOLLIES, FOOD OR STICKY SUBSTANCES** are allowed in the unit at any time. If upon pick up, such cleaning is required, a \$50 cleaning fee shall be automatically imposed.
- f) **DO NOT MOVE THE MEGAJUMPS UNIT FROM THE PLACE IT WAS INSTALLED.**
- g) Absolutely **NO PETS OR ANIMALS** are permitted on the inflatable unit, and must be kept clear at all times.

V. **SPECIAL INSTRUCTIONS:** The unit(s) equipment is reliable. Should the unit begin to deflate – the air blower may have stopped, in which case, check the power cord connection at the outlet, and check that the extension cord has not been unplugged. Check all tubes at the back of the unit for snugness and retie if necessary. If you cannot correct the problem, please call *MEGAJUMPS* on **0467586746**.

VI. **SAFE OPERATION ACKNOWLEDGEMENT:** Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the unit(s) that is subject of this Hire Agreement. Lessee agrees to observe all safety precautions. Lessee also represents and warrants the safe return of the unit(s) and hereby agrees to pay the full cost price on the hired item, if it is not returned.

VII. **MAINTENANCE:** Lessee agrees to keep the unit in the safe condition as when received, ordinary wear expected.

VIII. **ALTERATIONS AND ATTACHMENTS:** No alterations in or attachments to the unit(s) will be made without prior written approval from *MEGAJUMPS Castle & Party Hire*.

IX. **WARRANTY:** *MEGAJUMPS Castle & Party Hire* warrants that the unit(s) leased under this Rental Agreement will be in good working order on the effective date of the Rental Agreement. The unit(s) is supplied and maintained subject to this warranty. *MEGAJUMPS Castle & Party Hire* obligation under this Hire Agreement is limited to repair or replacement of the unit(s) when *MEGAJUMPS Castle & Party Hire* determines that it does not conform to this warranty. This warranty is in lieu of any and all other warranties expressed or implied, and of any and all obligations and liabilities on the part of *MEGAJUMPS Castle & Party Hire* for damages, including, but not limited to, consequential damages, arising out of or in connection with the use or performance of the unit(s).

X. **TITLE TO:** Lessee agrees to keep the *MEGAJUMPS Castle & Party Hire* unit(s) in his/her custody not to sublease, rent, sell, remove from the delivery address, or otherwise transfer such unit(s). The unit(s) will remain the property of *MEGAJUMPS Castle & Party Hire* and may be removed by *MEGAJUMPS Castle & Party Hire* at any time after the termination of this Rental Agreement.

XI. **RELEASE OF LIABILITY:** The Lessee shall be in charge of the unit’s operation, and is fully responsible for its operation as well as return of the *MEGAJUMPS* unit(s) in good working order. *MEGAJUMPS Castle & Party Hire* and its employees and agents are not responsible for injury occurring to the Lessee or any other persons using the unit(s), and the Lessee further agrees to hold *MEGAJUMPS Castle & Party Hire* and its employees and agents free and harmless against any injury or claims. The Lessee shall indemnify *MEGAJUMPS Castle & Party Hire* and its employees and agents from/against any costs incurred due to claims from anyone and for attorney’s fee and related costs involving the use and return of the unit(s), should legal action become necessary.

XII. **ENTIRE AGREEMENT:** This Rental Agreement constitutes the full agreement between *MEGAJUMPS Castle & Party Hire* and the Lessee. The receipt of the unit(s) that is the subject of this Rental Agreement is in good working order and repair, and this is so acknowledged by the Lessee.
