DEFINITION OF APPLICABLE USES OF EQUIPMENT, LOCATION OF USE OF EQUIPMENT, AND CONDITIONS APPLICABLE TO USE OF THE EQUIPMENT

1. The equipment shall only be used at the North Custer Rodeo Grounds in Challis, Idaho or at the Mackay Rodeo Grounds or Fairgrounds in Mackay.
2. The equipment shall only be used for activities that require the preparation of dirt surfaces in or in close proximity of the aforementioned arenas such as, but not limited to, High School Rodeos, Locally Sponsored Rodeos, Professionally Sanctioned Rodeos, Horse Shows, Community Events that utilize an arena for show or display of livestock, or Community Events with non-livestock show or display.
3. It is responsibility of the applicant to provide transportation of equipment to and from the two aforementioned arenas. A trailer or other mode of transportation will be used to haul the equipment. Equipment will not be roaded between Challis and Mackay.
4. The applicant will return the tractor with the fuel level (gasoline) equal to the pre-use amounts. All or a portion of the refundable deposit may be forfeited if the fuel level is not returned to pre-use levels.
5. The applicant is responsible for periodically checking the engine oil and hydraulic fluid during the period of use. The hydraulic fluid and engine oil capacities will be to OEM levels upon Pre-Inspection. Two (2) quarts of engine oil and one (1) gallon of hydraulic fluid will be provided if the applicant needs to add these fluids during use.
6. The equipment will either stay in its current location or be returned to the arena that is identified when the equipment receives it Pre-Inspection by a Fair Board Member. The refundable deposit will be forfeited if the equipment is not returned to it identified location within 5 days.
7. All or part of the refundable deposit may be forfeited if the equipment is returned damaged in any way or is not operable. Deposit forfeiture will be determined during the Post-Inspection. The applicant may also be billed for any damage beyond reasonable normal wear and tear and labor associated with returning it to its previous condition.
8. The applicant agrees not to assign this lease or sublet the said Custer County Arena Grooming Equipment.

I/We, the undersigned applicant, does hereby agree to the eight conditions set-forth above. In addition, the undersigned assumes full responsibility of the use of the Custer County Arena Grooming Equipment. The undersigned RELEASES from liability the Custer County Board of Commissioners or the Custer County Fair Board, its officers and members acting within the scope of their authority, from any and all claims arising from any injury, loss, damages, instruction, or expenses that I, or a someone in my group may incur as a result of use of any Custer County Arena Grooming Equipment. I represent that I am of lawful age and of sound mind, and have read and understand this RELEASE. Further, the undersigned will abide by all rules and regulations passed or adopted by the Custer County Board of Commissioners for said North Custer Rodeo Grounds and property.
