## Steps to submit a claim and receive your prepaid Visa card:

2. Include a copy of your sales receipt dated between 1/1/15 and 12/31/15 and proof of delivery date.
3. Include a dated invoice or receipt from a professional installer or contractor stating the cost to modify your existing countertop with a photograph of the before and after install.
