- Return the completed programme enrolment form, together with a crossed cheque in favour of The Hong Kong Management Association for Module Fee (HKMA Member: HK\$2,650 per module; Non-member: HK\$2,800 per module, Application Fee: HK100). Please write your FULL NAME and HKID CARD NO. on the back of the cheque.
