- I) General - Tourist/Visit Visa (a) Your valid passport (with atleast 6 months validity). (b) Two recent passport size photo graphs. (c) Required US\$ endorsement or sponsorship certificate in lieu.
- II) Business Visa-Attach business papers/invitation in support of your purpose.
- III) Visa on Medical ground - Produce Medical papers in support of your purpose.
- iv) Transit Visa- Produce photocopy of confirmed air tickets along with original tickets.
- v) Student Visa - Produce (a) Admission certificate from institute in India (b) NOC from Govt. of Bangladesh. (c) Bang guarantee. (d) US\$ endorsement (e) Photocopies of testimonials.

# CONDITION FOR ENTRY INTO INDIA

(Please read this section carefully)

## a) FILLING UP THE FORMS

Please complete the form in ink and write neatly in Block letters. You must answer all questions correctly and completely. False or misleading information may lead to refusal or cancellation of visa or penalties while in India. A representative may help you to fill up the Form but you must sign it.

b) Your visa application is liable to be rejected if you:

- i) Suffer from dangerous disease, such as Tuberculosis and AIDS
- ii) Suffer from mental illness.
- iii) Are addicted to or have trafficked in narcotics.
- iv) Have been convicted for or have criminal charges outstanding in any country.
- v) Have been deported or expelled from any country.

c) i) Even if you hold a valid entry clearance you can still be refused entry into India by the immigration officer if he is satisfied that :

- a) Your entry clearance was obtained false representation or by concealment of relevant facts, whether or not you were aware of that fact.
- b) A change in circumstances between the date of your application and your arrival in India invalidates your entry Clearance : or refusal is justified on the ground of restricted returnability medical ground, criminal record, because you are subject to a deportation order, your exclusion would be conducive to the public good.

ii) An immigration officer can ask anyone to be medically examined on arrival in India, if he considers necessary. If you

intend to stay in India longer than six months you could be required to have a medical examination before your entry clearance is issued.

iii) You must not undertake employment or formal study/research in India unless granted employment or student visa.

iv) You must leave India by the end of the authorised period of stay, unless extended by appropriate authority.

v) There may be other conditions, depending on the purpose of your visit. These conditions will be shown on your visa.
