Finishing Touches' Obligations

- Makeup Artist and Hair Stylist shall provide services with reasonable care and skill.
- Makeup Artist and Hair Stylist shall perform the services promptly on the date and time agreed.
- If Finishing Touches is unable to perform the agreed services for any unforeseeable reason or unavoidable situation, due to unforeseen circumstances or any other cause beyond her control, any and all payments shall be returned to the client with the understanding that there will be no further liability with respect to the agreement.
- Artist shall be the exclusive Makeup Artist for the Brides wedding.
- Finishing Touches shall use their own products in the provision of the services.
- Makeup Artist and Hair Stylist will use good quality professional materials.
